## A BILL

To require the Secretary of the Interior to issue new resource management plans applicable to the Beaver Dam Wash National Conservation Area and the Red Cliffs National Conservation Area and a new amendment to the St. George Field Office Resource Management Plan, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ISSUANCE OF NEW RESOURCE MANAGEMENT**  
2 **PLANS FOR THE BEAVER DAM WASH AND**  
3 **RED CLIFFS NATIONAL CONSERVATION**  
4 **AREAS AND A NEW AMENDMENT TO THE ST.**  
5 **GEORGE FIELD OFFICE RESOURCE MANAGE-**  
6 **MENT PLAN.**

7 The Secretary of the Interior (acting through the Di-  
8 rector of the Bureau of Land Management)—

9 (1) shall not implement or enforce the resource  
10 management plans for the Beaver Dam Wash Na-  
11 tional Conservation Area or the Red Cliffs National  
12 Conservation Area or the amendment to the St.  
13 George Field Office Resource Management Plan de-  
14 scribed in the notice of the Bureau of Land Manage-  
15 ment entitled “Notice of Availability of the Record  
16 of Decision and the Approved Resource Management  
17 Plans for the Beaver Dam Wash and Red Cliffs Na-  
18 tional Conservation Areas; and Approved Amend-  
19 ment to the St. George Field Office Resource Man-  
20 agement Plan in Washington County, Utah” (81  
21 Fed. Reg. 93707 (December 21, 2016)); and

22 (2) shall issue new resource management plans  
23 and a new amendment to replace the resource man-  
24 agement plans and amendment to the resource man-  
25 agement plan referred to in paragraph (1) that are  
26 prepared—

1           (A) in accordance with the requirements  
2           for management plans established under sub-  
3           title O of title I of the Omnibus Public Land  
4           Management Act of 2009 (Public Law 111–11;  
5           123 Stat. 1075); and

6           (B) in coordination with affected units of  
7           local government, in accordance with section  
8           202(c)(9) of the Federal Land Policy and Man-  
9           agement Act of 1976 (43 U.S.C. 1712(c)(9)).
