A BILL

To amend the General Education Provisions Act to prohibit Federal education funding for elementary or secondary schools that provide access to emergency postcoital contraception.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Schoolchildren’s
3 Health Protection Act”.

4 **SEC. 2. SCHOOLCHILDREN’S HEALTH PROTECTION.**

5 The General Education Provisions Act (20 U.S.C.
6 1221 et seq.) is amended by adding at the end the fol-
7 lowing new part:

8 **“PART E—SCHOOLCHILDREN’S HEALTH**
9 **PROTECTION**

10 **“SEC. 461. LIMITATION ON FUNDING.**

11 “Notwithstanding any other provision of Federal law,
12 no funds shall be made available from any applicable pro-
13 gram to a State educational agency or local educational
14 agency that distributes or provides postcoital emergency
15 contraception (such as the so-called ‘morning-after pill’)
16 or a prescription for such contraception on the premises,
17 or in the facilities, of an elementary school or secondary
18 school.

19 **“SEC. 462. DEFINITION.**

20 “In this part, the term ‘postcoital emergency contra-
21 ception’ means—

22 “(1) any of the regimens described in the notice
23 entitled ‘Prescription Drug Products; Certain Com-
24 bined Oral Contraceptives for Use as Postcoital
25 Emergency Contraception’, published in the Federal

1 Register on February 25, 1997 (62 FR 8610), or
2 any subsequent corresponding notice; or

3 “(2) any other drug or device to be used after
4 fertilization may have occurred and for the same
5 purposes as the regimes in subparagraph (A).”.
