## A BILL

To amend title XXVII of the Public Health Service Act and title XVIII of the Social Security Act to require pharmacies to disclose any differential between the cost of a prescription drug based on whether certain individuals use prescription drug coverage to acquire such drug, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Lowest Price for Pa-  
3 tients Act”.

4 **SEC. 2. REQUIREMENT FOR PHARMACIES TO DISCLOSE**  
5 **ANY DIFFERENTIAL BETWEEN THE COST OF**  
6 **A PRESCRIPTION DRUG BASED ON WHETHER**  
7 **CERTAIN INDIVIDUALS USE PRESCRIPTION**  
8 **DRUG COVERAGE TO ACQUIRE SUCH DRUG.**

9 (a) ENROLLEES OF PRESCRIPTION DRUG COVERAGE  
10 UNDER A GROUP HEALTH PLAN OR A HEALTH INSUR-  
11 ANCE ISSUER OFFERING GROUP OR INDIVIDUAL HEALTH  
12 INSURANCE COVERAGE.—Section 2729(a) of the Public  
13 Health Service Act (42 U.S.C. 300gg–29(a)) is amend-  
14 ed—

15 (1) in paragraph (1)—

16 (A) by striking “not restrict, directly or in-  
17 directly,” and inserting “provide that”; and

18 (B) by striking “from informing (or penal-  
19 ize such pharmacy for informing)” and insert-  
20 ing “inform”; and

21 (2) in paragraph (2)—

22 (A) by striking “ensure” and inserting  
23 “provide”;

24 (B) by striking “does not, with respect to  
25 such plan or coverage, restrict, directly or indi-

1           rectly,” and inserting “requires under such con-  
2           tract that”; and

3                   (C) by striking “from informing (or penal-  
4           ize such pharmacy for informing)” and insert-  
5           ing “inform”.

6           (b) ENROLLEES OF PRESCRIPTION DRUG COVERAGE  
7 UNDER A PRESCRIPTION DRUG PLAN OR MA-PD  
8 PLAN.—Section 1860D-4 of the Social Security Act (42  
9 U.S.C. 1395w-104) is amended—

10           (1) by redesignating the subsection (m) as in-  
11           serted by section 6063(c) of the SUPPORT for Pa-  
12           tients and Communities Act as subsection (n); and

13           (2) by adding at the end the following new sub-  
14           section:

15           “(o) PHARMACY DISCLOSURE OF THE PRICE OF A  
16 DRUG FOR AN ENROLLEE USING AND NOT USING PRE-  
17 SCRIPTION DRUG COVERAGE.—For plan year 2022 and  
18 each subsequent plan year, a PDP sponsor and a Medicare  
19 Advantage organization offering a prescription drug plan  
20 or MA-PD plan under a contract with an entity that pro-  
21 vides pharmacy benefits management services on behalf  
22 of such MA-PD plan shall provide that each pharmacy  
23 that dispenses a coverage part D drug shall inform an en-  
24 rollee of any differential between—

1           “(1) the price of the drug for an individual that  
2           is an enrollee under such prescription drug plan or  
3           MA–PD plan (as the case may be) using such plan;  
4           and

5           “(2) the price of the drug for such individual  
6           described in paragraph (1) without using such  
7           plan.”.
