## A BILL

To direct the Administrator of the Small Business Administration to establish a competitive grant program to award grants to States and local governments for purposes of assisting entrepreneurs planning to start a small business concern.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Startup in a Day Act  
5 of 2017”.

1 **SEC. 2. STARTUP IN A DAY GRANT PROGRAM.**

2 (a) ESTABLISHMENT.—The Administrator of the  
3 Small Business Administration shall, from amounts ap-  
4 propriated pursuant to subsection (g), establish a competi-  
5 tive grant program to be known as the “Startup in a Day  
6 Program” to award grants to eligible entities for purposes  
7 of assisting entrepreneurs planning to start a small busi-  
8 ness concern in complying with State or local government  
9 requirements for opening and operating such a concern  
10 in a geographic area in the jurisdiction of the eligible enti-  
11 ty.

12 (b) APPLICATION.—An eligible entity may submit an  
13 application to the Administrator, at a time and in a man-  
14 ner to be prescribed by the Administrator, describing ac-  
15 tivities the eligible entity would undertake to assist entre-  
16 preneurs planning to start a small business concern in a  
17 geographic area in the jurisdiction of the eligible entity.

18 (c) SELECTION.—The Administrator shall select from  
19 among eligible entities submitting an application pursuant  
20 to subsection (b) grant recipients based on criteria to be  
21 prescribed by the Administrator.

22 (d) AUTHORIZED USE OF FUNDS.—Grants awarded  
23 under this section may be used by a grant recipient to  
24 carry out activities to assist entrepreneurs planning to  
25 start small business concerns, including—

1           (1) developing, implementing, and improving  
2 Internet resources related to the small business con-  
3 cern startup process in the geographic area in the  
4 jurisdiction of the recipient;

5           (2) assisting such entrepreneurs in registering  
6 and applying for any licenses or permits required by  
7 a State or a local government for starting a small  
8 business concern in such area; and

9           (3) other activities the Administrator deter-  
10 mines necessary.

11 (e) REPORTS.—

12           (1) REPORT TO ADMINISTRATOR.—A recipient  
13 of a grant under this section shall submit to the Ad-  
14 ministrator, at a time and in a manner to be pre-  
15 scribed by the Administrator, a report detailing how  
16 grant funds were expended and describing the im-  
17 pact, if any, of activities funded by the grant on the  
18 opening of small business concerns in a geographic  
19 area in the jurisdiction of such recipient.

20           (2) REPORT TO CONGRESS.—Not later than 90  
21 days after the conclusion of each fiscal year for  
22 which the Administrator awards a grant under this  
23 section, the Administrator shall submit to Congress  
24 a report describing all such grants awarded for such  
25 fiscal year and analyzing the impact, if any, of such

1 grants on the opening of small business concerns in  
2 the jurisdictions of eligible entities receiving such  
3 grants.

4 (f) DEFINITIONS.—For purposes of this section, the  
5 following definitions apply:

6 (1) ADMINISTRATOR.—The term “Adminis-  
7 trator” means the Administrator of the Small Busi-  
8 ness Administration.

9 (2) ELIGIBLE ENTITY.—The term “eligible enti-  
10 ty” means a State or local government.

11 (3) LOCAL GOVERNMENT.—The term “local  
12 government” means a county, parish, borough, or  
13 municipal government.

14 (4) SMALL BUSINESS CONCERN.—The term  
15 “small business concern” has the meaning given  
16 such term under section 3 of the Small Business Act  
17 (15 U.S.C. 632).

18 (5) STATE.—The term “State” means each of  
19 the several States, the District of Columbia, the  
20 Commonwealth of Puerto Rico, the Virgin Islands of  
21 the United States, Guam, American Samoa, the  
22 Commonwealth of the Northern Mariana Islands,  
23 and each federally recognized Indian tribe.

24 (g) AUTHORIZATION OF APPROPRIATIONS.—There  
25 are authorized to be appropriated to the Administrator for

1 each of fiscal years 2018 through 2022 \$1,000,000 for  
2 purposes of carrying out this section.
