A BILL

To redesignate the Pullman National Monument in the State of Illinois as the Pullman National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Pullman National His-*
5 *torical Park Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *HISTORICAL PARK.*—*The term “historical*
9 *park” means the Pullman National Historical Park*
10 *established in section 3(a).*

11 (2) *SECRETARY.*—*The term “Secretary” means*
12 *the Secretary of the Interior.*

13 **SEC. 3. REDESIGNATION OF PULLMAN NATIONAL MONU-**
14 **MENT.**

15 (a) *IN GENERAL.*—*There is established the Pullman*
16 *National Historical Park for the purposes set forth in this*
17 *Act.*

18 (b) *ABOLISHMENT OF MONUMENT, INCORPORATION OF*
19 *LANDS, AND AVAILABILITY OF FUNDS.*—*The Pullman Na-*
20 *tional Monument, established by Proclamation Number*
21 *9233, dated February 19, 2015, is abolished as such, and*
22 *all lands or interests in land that constitute the Monument*
23 *(as in existence on the day before the date of enactment of*
24 *this Act) are incorporated in, and shall be considered to*
25 *be part of, the historical park. Any funds available for pur-*

1 *poses of the Pullman National Monument shall be available*
2 *for purposes of the historical park.*

3 (c) *REFERENCES.*—*Any references in a law, regula-*
4 *tion, document, record, map, or other paper of the United*
5 *States to the Pullman National Monument shall be consid-*
6 *ered to be a reference to the historical park.*

7 **SEC. 4. PURPOSES.**

8 *The purposes of the historical park are to preserve,*
9 *protect, and interpret Pullman’s nationally significant cul-*
10 *tural and historical resources associated with—*

11 (1) *the Nation’s labor history and creation of a*
12 *national Labor Day holiday;*

13 (2) *the first planned model industrial commu-*
14 *nity in the United States;*

15 (3) *the architecture and landscape design of the*
16 *planned community;*

17 (4) *the pivotal role of the Pullman porter in the*
18 *rise of the African-American middle class; and*

19 (5) *the entirety of the history, and historic fig-*
20 *ures discussed in Presidential Proclamation Number*
21 *9233.*

22 **SEC. 5. BOUNDARIES.**

23 (a) *IN GENERAL.*—*The boundaries of the historical*
24 *park are as generally depicted on the map entitled “Pull-*

1 *man National Historical Park*”, numbered 590-125,485,
2 *and dated November 2021.*

3 (b) *ACQUISITION OF LAND.*—*The Secretary may ac-*
4 *quire land, including interests in land, within the bound-*
5 *aries of the historical park by donation, transfer, exchange,*
6 *or purchase from a willing seller using donated or appro-*
7 *priated funds.*

8 (c) *AVAILABILITY OF MAP.*—*The map shall be on file*
9 *and available for public inspection in the appropriate of-*
10 *fices of the National Park Service and the Department of*
11 *the Interior.*

12 **SEC. 6. ADMINISTRATION.**

13 *The Secretary shall administer the land within the*
14 *boundary of the historical park in accordance with—*

15 (1) *this Act; and*

16 (2) *the laws generally applicable to units of the*
17 *National Park System, including—*

18 (A) *section 100101(a), chapter 1003, and*
19 *sections 100751(a), 100752, 100753 and 102101*
20 *of title 54, United States Code; and*

21 (B) *chapter 3201 of title 54, United States*
22 *Code.*

23 **SEC. 7. COOPERATIVE AGREEMENTS.**

24 (a) *IN GENERAL.*—*The Secretary may enter into coop-*
25 *erative agreements with the State, other public and non-*

1 *profit entities, and other interested parties to identify, in-*
2 *terpret, and provide technical assistance, including collabo-*
3 *rative interpretive and educational programs, at—*

4 (1) *non-Federal historic properties within the*
5 *boundaries of the historical park; and*

6 (2) *sites in close proximity to the historical park,*
7 *but located outside the boundaries of the historical*
8 *park, including providing for placement of directional*
9 *and interpretive signage, exhibits, and technology-*
10 *based interpretive devices.*

11 (b) *PRESERVATION.—The Secretary may enter into co-*
12 *operative agreements with the State, other public and non-*
13 *profit entities, and other interested parties to provide finan-*
14 *cial assistance to mark, interpret, and restore non-Federal*
15 *nationally significant historic or cultural properties and re-*
16 *sources within the historical park as the Secretary deter-*
17 *mines appropriate to carry out the purposes of this Act.*
18 *These cooperative agreements will be subject to such terms*
19 *and conditions that the Secretary determines necessary, and*
20 *shall provide that—*

21 (1) *reasonable public access to the property cov-*
22 *ered by such agreement for the purpose of interpreting*
23 *them to the public;*

1 (2) *no changes or alterations shall be made to the*
2 *exterior of the properties except by mutual agreement*
3 *of the other parties to the agreements;*

4 (3) *the Federal share of the total cost of any ac-*
5 *tivity carried out under the agreement shall be not*
6 *more than 50 percent, with in-kind contributions or*
7 *goods or services fairly valued authorized, as appro-*
8 *priate, for the non-Federal share; and*

9 (4) *any conversion, use, or disposal of the re-*
10 *stored property for purposes that are inconsistent*
11 *with the purposes of this subsection, as determined by*
12 *the Secretary, shall result in a right of the United*
13 *States to reimbursement of the greater of—*

14 (A) *the amount provided by the Secretary*
15 *to the project; or*

16 (B) *an amount equal to the increase in the*
17 *value of the project that is attributable to the*
18 *funds, as determined by the Secretary at the*
19 *time of the conversion, use, or disposal.*

20 **SEC. 8. MANAGEMENT PLAN.**

21 *Not later than 3 years after the date on which funds*
22 *are first made available to carry out this Act, the Secretary*
23 *shall complete a general management plan for the historical*
24 *park in accordance with section 100502 of title 54.*
