3 SECTION 1. SHORT TITLE; REFERENCES TO PPACA.

- 4 (a) SHORT TITLE.—This Act may be cited as the
 5 "Medicare Firewall Act of 2011".
- 6 (b) REFERENCES.—In this Act, the term "PPACA"

8	the Medicare Improvements for Patients and Pro-
9	viders Act of 2008 (42 U.S.C. 1395b–3 note), as
10	amended by section 3306 of PPACA, are each
11	amended—
12	(A) in clause (ii), by striking "through
13	2012" and inserting "and 2011"; and
14	(B) by striking "shall remain available
15	until expended" and inserting "shall remain
16	available through the date of the enactment of
17	the Medicare Firewall Act of 2011".
18	(2) Rescission of unobligated balance.—
19	Of the amounts transferred under such subsections
20	on or before the date of the enactment of this Act,
21	the unobligated balances shall be transferred back

11 the Medicare Firewall Act of 2011.".

12 (2)RESTORATION \mathbf{OF} UNOBLIGATED BAL-13 ANCE.—Of the amounts transferred under such sec-14 tion on or before the date of the enactment of this 15 Act, the unobligated balance shall be transferred 16 back into the Medicare Trust Fund or Funds from 17 which it was transferred.

18 SEC. 3. ACCOUNTABILITY FOR TRUST FUND DEMONSTRA-

TION PROJECT EXPENDITURES.

(a) IN GENERAL.—Not later than 1 year after the
date of the enactment of this Act, the Secretary of Health
and Human Services shall submit to the Congress a report
that describes covered demonstration projects and identifies those projects for which initial period of the project
has—

(1) not demonstrated that the project has met
 the objectives specified for the project; or

3 (2) resulted in net expenditures from the Medi-4 care Trust Funds.

5 (b) PLAN FOR TERMINATION OR MODIFICATION.—
6 For those covered demonstration projects identified under
7 subsection (a), the Secretary shall include the report
8 under such subsection a plan for the termination or modi9 fication of each such project.

10 (c) COVERED DEMONSTRATION PROJECT.—In this 11 section, the term "covered demonstration project" means 12 a demonstration, pilot, or similar project undertaken with 13 some or all funding from any of the Medicare Trust 14 Funds.
