To provide for reimbursement for the use of modern travel services by Federal employees traveling on official Government business, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Modernizing Govern-
- 3 ment Travel Act".
- 4 SEC. 2. FEDERAL EMPLOYEE REIMBURSEMENT FOR USE
- 5 OF MODERN TRAVEL SERVICES.
- 6 (a) IN GENERAL.—Not later than 90 days after the
- 7 date of enactment of this Act, the Administrator of Gen-
- 8 eral Services shall prescribe regulations under section
- 9 5707 of title 5, United States Code, to provide for the
- 10 reimbursement for the use of a transportation network
- 11 company or innovative mobility technology company by
- 12 any Federal employee traveling on official business under
- 13 subchapter I of chapter 57 of such title, except that the
- 14 Director of the Administrative Office of the United States
- 15 Courts shall prescribe such regulations with respect to em-
- 16 ployees of the judicial branch of the Government.
- 17 (b) Definitions.—In this section:
- 18 (1) Innovative mobility technology com-
- 19 PANY.—The term "innovative mobility technology
- company' means an organization, including a cor-
- 21 poration, limited liability company, partnership, sole
- proprietorship, or any other entity, that applies tech-
- 23 nology to expand and enhance available transpor-
- tation choices, better manages demand for transpor-
- 25 tation services, or provides alternatives to driving
- alone.

1	(2) Transportation Network Company.—
2	The term "transportation network company"—
3	(A) means a corporation, partnership, sole
4	proprietorship, or other entity, that uses a dig-
5	ital network to connect riders to drivers affili-
6	ated with the entity in order for the driver to
7	transport the rider using a vehicle owned
8	leased, or otherwise authorized for use by the
9	driver to a point chosen by the rider; and

11	pool or vanpool arrangement that is not in-
12	tended to generate profit for the driver.

18	tion 901(b) of title 31 and a survey of such data for
19	each other agency; and

- 1 "(B) a description of any new regulations pro-
- 2 mulgated or changes to existing regulations author-
- 3 ized under this section.".
