## A BILL

To amend title XVIII of the Social Security Act to provide for coverage under the Medicare program of pharmacist services.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pharmacy and Medi-  
5 cally Underserved Areas Enhancement Act”.

1 **SEC. 2. MEDICARE COVERAGE OF PHARMACIST SERVICES.**

2 (a) COVERAGE.—Section 1861(s)(2) of the Social Se-  
3 curity Act (42 U.S.C. 1395x(s)(2)) is amended—

4 (1) by striking “and” at the end of subpara-  
5 graph (GG);

6 (2) by striking the period at the end and insert-  
7 ing “; and” at the end of subparagraph (HH); and

8 (3) by inserting after subparagraph (HH) the  
9 following new subparagraph at the end:

10 “(II) pharmacist services furnished by a  
11 pharmacist, as licensed by State law, individ-  
12 ually or on behalf of a pharmacy provider—

13 “(i) which the pharmacist is legally  
14 authorized to perform in the State in  
15 which the individual performs such serv-  
16 ices;

17 “(ii) as would otherwise be covered  
18 under this part if furnished by a physician,  
19 or as an incident to a physician’s service;  
20 and

21 “(iii) in a setting located in a health  
22 professional shortage area (as defined in  
23 section 332(a)(1)(A) of the Public Health  
24 Service Act), medically underserved area,  
25 or medically underserved population (as  
26 defined in section 330(b)(3) of such Act).”.

1 (b) PAYMENT.—Section 1833(a)(1) of the Social Se-  
2 curity Act (42 U.S.C. 1395l(a)(1)) is amended—

3 (1) by striking “and (DD)” and inserting  
4 “(DD)”; and

5 (2) by inserting before the semicolon at the end  
6 the following: “and (EE) with respect to pharmacist  
7 services (as defined in section 1861(s)(2)(II)), the  
8 amounts paid shall be equal to 80 percent of the  
9 lesser of the actual charge or 85 percent of the fee  
10 schedule amount provided under section 1848 if  
11 such services had been furnished by a physician”.

12 (c) EFFECTIVE DATE; PHARMACIST SPECIFIC  
13 CODES.—

14 (1) EFFECTIVE DATE.—The amendments made  
15 by subsections (a) and (b) shall apply with respect  
16 to services furnished on or after January 1, 2022.

17 (2) PHARMACIST SPECIFIC CODES.—The Sec-  
18 retary of Health and Human Services shall develop  
19 pharmacist specific codes, as necessary, under the  
20 physician fee schedule under section 1848 of the So-  
21 cial Security Act (42 U.S.C. 1395w-4).
