AN ACT

To amend the Social Security Act to make certain revisions to provisions limiting payment of benefits to fugitive felons under titles II, VIII, and XVI of the Social Security Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Control Unlawful Fu-
3 gitive Felons Act of 2017”.

4 **SEC. 2. REVISIONS TO PROVISIONS LIMITING PAYMENT OF**
5 **BENEFITS TO FUGITIVE FELONS UNDER**
6 **TITLE XVI OF THE SOCIAL SECURITY ACT.**

7 (a) FUGITIVE FELON WARRANT REQUIREMENT.—
8 Section 1611(e)(4)(A)(i) of the Social Security Act (42
9 U.S.C. 1382(e)(4)(A)(i)) is amended—

10 (1) by striking “fleeing to avoid” and inserting
11 “the subject of an arrest warrant for the purpose
12 of”;

13 (2) by striking “the place from which the per-
14 son flees” the first place it appears and inserting
15 “the jurisdiction issuing the warrant”; and

16 (3) by striking “the place from which the per-
17 son flees” the second place it appears and inserting
18 “the jurisdiction”.

19 (b) PROBATION AND PAROLE WARRANT REQUIRE-
20 MENT.—Section 1611(e)(4)(A)(ii) of such Act (42 U.S.C.
21 1382(e)(4)(A)(ii)) is amended to read as follows:

22 “(ii) the subject of an arrest warrant for vio-
23 lating a condition of probation or parole imposed
24 under Federal or State law.”.

25 (c) DISCLOSURE.—Section 1611(e)(5) of such Act
26 (42 U.S.C. 1382(e)(5)) is amended—

1 (1) by striking “any recipient of” and inserting
2 “any individual who is a recipient of (or would be
3 such a recipient but for the application of paragraph
4 (4)(A))”; and

5 (2) by striking “the recipient” each place it ap-
6 pears and inserting “the individual”.

7 (d) **EFFECTIVE DATE.**—The amendments made by
8 this section shall be effective with respect to benefits pay-
9 able for months that begin on or after January 1, 2021.
