A BILL

To amend the Violent Crime Control and Law Enforcement Act of 1994 to reauthorize the Missing Alzheimer's Disease Patient Alert Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Missing Alzheimer’s
5 Disease Patient Alert Program Reauthorization of 2011”.

6 **SEC. 2. REAUTHORIZATION OF THE MISSING ALZHEIMER’S**

7 **DISEASE PATIENT ALERT PROGRAM.**

8 Section 240001 of the Violent Crime Control and
9 Law Enforcement Act of 1994 (42 U.S.C. 14181) is
10 amended—

11 (1) by amending subsection (a) to read as fol-
12 lows:

13 “(a) GRANT.—Subject to the availability of appro-
14 priations to carry out this section, the Attorney General,
15 through the Bureau of Justice Assistance and in consulta-
16 tion with the Secretary of Health and Human Services,
17 shall award competitive grants to nonprofit organizations
18 to assist such organizations in paying for the costs of plan-
19 ning, designing, establishing, and operating locally based,
20 proactive programs to protect and locate missing patients
21 with Alzheimer’s disease and related dementias and other
22 missing elderly individuals.”;

23 (2) in subsection (b)—

24 (A) by inserting “competitive” after “to re-
25 ceive a”, and

1 (B) by adding at the end the following new
2 sentence: “The Attorney General shall periodi-
3 cally solicit applications for grants under this
4 section by publishing a request for applications
5 in the Federal Register and by posting such a
6 request on the Web site of the Department of
7 Justice.”;

8 (3) by amending subsection (e) to read as fol-
9 lows:

10 “(e) PREFERENCE.—In awarding grants under sub-
11 section (a), the Attorney General shall give preference to
12 national nonprofit organizations that have a direct link to
13 patients, and families of patients, with Alzheimer’s disease
14 and related dementias.”; and

15 (4) by amending subsection (d) to read as fol-
16 lows:

17 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
18 are authorized to be appropriated to carry out this section
19 \$5,000,000 for each of the fiscal years 2012 through
20 2018.”.

21 **SECTION 1. SHORT TITLE.**

22 *This Act may be cited as the “Missing Alzheimer’s Dis-
23 ease Patient Alert Program Reauthorization Act of 2012”.*

10 *petitive grants to nonprofit organizations to assist such or-*

11 *ganizations in paying for the costs of planning, designing,*

12 *establishing, and operating locally based, proactive pro-*

13 *grams to protect and locate missing patients with Alz-*

14 *heimer's disease and related dementias.";*

15 *(2) in subsection (b), by inserting "competitive"*

16 *after "to receive a";*

17 *(3) by amending subsection (c) to read as fol-*

18 *lows:*

19 *"(c) PREFERENCE.—In awarding grants under sub-*

20 *section (a), the Attorney General shall give preference to*

21 *national nonprofit organizations that have experience work-*

22 *ing with patients, and families of patients, with Alz-*

23 *heimer's disease and related dementias."; and*

24 *(4) by amending subsection (d) to read as fol-*

25 *lows:*

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
2 are authorized to be appropriated to carry out this section
3 \$1,000,000 for each of the fiscal years 2013 through 2017.”.
