# **A BILL**

To amend title 54, United States Code, to extend the authorization of appropriations for the Historic Preservation Fund.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Historic Pres-*  
5 *ervation Amendments Act”.*

6 **SEC. 2. REAUTHORIZATION OF THE HISTORIC PRESERVA-**  
7 **TION FUND.**

8 *(a) IN GENERAL.—Section 303102 of title 54, United*  
9 *States Code, is amended by striking “2015” and inserting*  
10 *“2023”.*

11 *(b) FEDERAL NOMINATIONS.—Section 302104 of such*  
12 *title is amended—*

13 *(1) in subsections (a) and (b) by striking “sub-*  
14 *section (c)” and inserting “subsection (d)”;*

15 *(2) by inserting after subsection (b), the fol-*  
16 *lowing new subsection:*

17 *“(c) NOMINATION BY FEDERAL AGENCY.—Subject to*  
18 *the requirements of section 302107 of this title, the regula-*  
19 *tions promulgated under section 302103 of this title, and*  
20 *appeal under subsection (d) of this section, the Secretary*  
21 *may accept a nomination directly by a Federal agency for*  
22 *inclusion of property on the National Register only if—*

23 *“(1) completed nominations are sent to the State*  
24 *Historic Preservation Officer for review and comment*  
25 *regarding the adequacy of the nomination, the signifi-*

1        *cance of the property and its eligibility for the Na-*  
2        *tional Register;*

3            *“(2) within 45 days of receiving the completed*  
4        *nomination, the State Historic Preservation Officer*  
5        *has made a recommendation regarding the nomina-*  
6        *tion to the Federal Preservation Officer, except that*  
7        *failure to meet this deadline shall constitute a rec-*  
8        *ommendation to not support the nomination;*

9            *“(3) the chief elected officials of the county (or*  
10        *equivalent governmental unit) and municipal polit-*  
11        *ical jurisdiction in which the property is located are*  
12        *notified and given 45 days in which to comment;*

13            *“(4) the Federal Preservation Officer forwards it*  
14        *to the Keeper of the National Register of Historic*  
15        *Places after determining that all procedural require-*  
16        *ments have been met, including those in paragraphs*  
17        *(1) through (3) above; the nomination is adequately*  
18        *documented; the nomination is technically and profes-*  
19        *sionally correct and sufficient; and may include an*  
20        *opinion as to whether the property meets the National*  
21        *Register criteria for evaluation;*

22            *“(5) notice is provided in the Federal Register*  
23        *that the nominated property is being considered for*  
24        *listing on the National Register that includes any*  
25        *comments and the recommendation of the State His-*

1        *toric Preservation Officer and a declaration whether*  
2        *the State Historic Preservation Officer has responded*  
3        *within the 45 day-period of review provided in para-*  
4        *graph (2); and*

5                *“(6) the Secretary addresses in the Federal Reg-*  
6        *ister any comments from the State Historic Preserva-*  
7        *tion Officer that do not support the nomination of the*  
8        *property on the National Register before the property*  
9        *is included in the National Register.”; and*

10                *(3) by redesignating subsection (c) as subsection*  
11        *(d).*

12        *(c) TECHNICAL AMENDMENTS.—*

13                *(1) Section 303102 of such title is amended by*  
14        *striking “**Contents**” in the heading thereof and in-*  
15        *serting “**Funding**”.*

16                *(2) The table of sections for chapter 3031 of such*  
17        *title is amended by striking the item relating to sec-*  
18        *tion 303102 and inserting the following new item:*

*“303102. Funding.”.*
