## A BILL

To direct the Secretary of Defense to carry out a pilot program to lend Department of Defense farm equipment to eligible farmers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Equip Ag Act of  
5 2017”.

1 **SEC. 2. DEPARTMENT OF DEFENSE FARM EQUIPMENT**  
2 **SHARING PILOT PROGRAM.**

3 (a) SURVEY OF DOD EQUIPMENT.—Not later than  
4 one year after the date of the enactment of this Act, the  
5 Secretary of Defense, in consultation with the Secretary  
6 of Agriculture, shall conduct a survey of the equipment  
7 of the Department of Defense to determine which such  
8 equipment—

9 (1) would be appropriate for use by farmers  
10 through an equipment sharing program; and

11 (2) could be used in an equipment sharing pro-  
12 gram without jeopardizing military readiness.

13 (b) PILOT PROGRAM.—

14 (1) IN GENERAL.—The Secretary of Defense  
15 shall establish a pilot program under which the Sec-  
16 retary shall lend equipment of the Department iden-  
17 tified pursuant to the survey carried out under sub-  
18 section (a) to eligible farmers.

19 (2) ELIGIBILITY.—To be eligible to borrow  
20 equipment under the pilot program, a farmer shall—

21 (A) be a new and beginning farmer, as de-  
22 termined by the Secretary; and

23 (B) submit to the Secretary an application  
24 containing such information and assurances as  
25 the Secretary may require.

1           (3) LOCATION.—The Secretary shall carry out  
2 the pilot program at locations determined by the  
3 Secretary.

4           (4) DURATION.—The authority to carry out a  
5 pilot program under this section shall terminate on  
6 the date that is three years after the date of the  
7 commencement of the pilot program.

8           (5) REPORT.—Not later than 60 days after the  
9 termination of the pilot program under this sub-  
10 section, the Secretary shall submit to Congress a re-  
11 port on the pilot program that includes the rec-  
12 ommendations of the Secretary with respect to the  
13 extension and expansion of the program.
