A BILL

To amend title I of the Patient Protection and Affordable Care Act to provide that only health plans made available by the Federal Government to Supreme Court Justices and staff are Exchange health plans.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “SCOTUScare Act of
5 2015”.

1 **SEC. 2. SUPREME COURT JUSTICES AND STAFF IN THE EX-**
2 **CHANGE.**

3 Section 1312(d)(3) of the Patient Protection and Af-
4 fordable Care Act (42 U.S.C. 18032(d)(3)) is amended by
5 adding at the end the following new subparagraph:

6 “(E) SUPREME COURT JUSTICES AND
7 STAFF IN THE EXCHANGE.—

8 “(i) REQUIREMENT.—Notwith-
9 standing any other provision of law, for
10 plan years beginning after the date of the
11 enactment of the SCOTUScare Act of
12 2015, the only health plans that the Fed-
13 eral Government may make available to
14 Justices of the Supreme Court and Su-
15 preme Court staff with respect to their
16 service as a Justice of the Supreme Court
17 or Supreme Court staff shall be health
18 plans that are—

19 “(I) created under this Act (or
20 an amendment made by this Act); or

21 “(II) offered through an Ex-
22 change established under this Act (or
23 an amendment made by this Act).

24 “(ii) DEFINITIONS.—In this section:

25 “(I) JUSTICE OF THE SUPREME
26 COURT.—The term ‘Justice of the Su-

1 preme Court' means any Associate
2 Justice or Chief Justice of the Su-
3 preme Court of the United States.

4 “(II) SUPREME COURT STAFF.—
5 The term ‘Supreme Court staff’
6 means any individual who is an em-
7 ployee of the Supreme Court of the
8 United States.”.
