A BILL

To reauthorize and enhance Johanna's Law to increase public awareness and knowledge with respect to gynecologic cancers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION AND ENHANCEMENT OF**
4 **JOHANNA’S LAW.**

5 *(a) IN GENERAL.—Section 317P(d) of the Public*
6 *Health Service Act (42 U.S.C. 247b–17(d)(4)) is amend-*
7 *ed—*

8 *(1) in paragraph (4), by inserting after “2009”*
9 *the following: “and \$18,000,000 for the period of fis-*
10 *cal years 2012 through 2014”; and*

11 *(2) by redesignating paragraph (4) as para-*
12 *graph (6).*

13 *(b) CONSULTATION WITH NONPROFIT GYNECOLOGIC*
14 *CANCER ORGANIZATIONS.—Section 317P(d) of such Act (42*
15 *U.S.C. 247b–17(d)), as amended by subsection (a), is fur-*
16 *ther amended by inserting after paragraph (3) the fol-*
17 *lowing:*

18 *“(4) CONSULTATION WITH NONPROFIT*
19 *GYNECOLOGIC CANCER ORGANIZATIONS.—In carrying*
20 *out the national campaign under this subsection, the*
21 *Secretary shall consult with the leading nonprofit*
22 *gynecologic cancer organizations, with a mission both*
23 *to conquer ovarian or other gynecologic cancer na-*
24 *tionwide and to provide outreach to State and local*
25 *governments and communities, for the purpose of de-*

1 *termining the best practices for providing gynecologic*
2 *cancer information and outreach services to varied*
3 *populations.”.*

4 **SEC. 2. DEMONSTRATION PROJECTS REGARDING OUT-**
5 **REACH AND EDUCATION STRATEGIES RELAT-**
6 **ING TO GYNECOLOGIC CANCER.**

7 *(a) IN GENERAL.—Section 317P(d) of the Public*
8 *Health Service Act (42 U.S.C. 247b–17(d)), as amended by*
9 *section 1, is further amended by inserting after paragraph*
10 *(4) the following:*

11 *“(5) DEMONSTRATION PROJECTS REGARDING*
12 *OUTREACH AND EDUCATION STRATEGIES.—*

13 *“(A) IN GENERAL.—The Secretary may*
14 *carry out a program to award grants or con-*
15 *tracts to public or nonprofit private entities for*
16 *the purpose of carrying out demonstration*
17 *projects to test and compare different evidence-*
18 *based outreach and education strategies to in-*
19 *crease the awareness and knowledge of women*
20 *and health care providers with respect to*
21 *gynecologic cancers, including early warning*
22 *signs, risk factors, prevention, screening, and*
23 *treatment options. Such strategies shall include*
24 *efforts directed at women and their families,*
25 *physicians, nurses, and key health professionals.*

1 “(B) *PREFERENCES IN AWARDING GRANTS*
2 *OR CONTRACTS.*—*In making awards under sub-*
3 *paragraph (A), the Secretary shall give pref-*
4 *erence to—*

5 “(i) *applicants with demonstrated ex-*
6 *pertise in gynecologic cancer education or*
7 *treatment or in working with groups of*
8 *women who are at increased risk of*
9 *gynecologic cancers; and*

10 “(ii) *applicants that, in the dem-*
11 *onstration project funded by the grant or*
12 *contract, will establish linkages between*
13 *physicians, nurses, and key health profes-*
14 *sionals, health profession students, hospitals,*
15 *payers, and State health departments.*

16 “(C) *APPLICATION.*—*To seek a grant or*
17 *contract under subparagraph (A), an entity shall*
18 *submit an application to the Secretary in such*
19 *form, in such manner, and containing such*
20 *agreements, assurances, and information as the*
21 *Secretary determines to be necessary to carry out*
22 *this paragraph.*

23 “(D) *CERTAIN REQUIREMENTS.*—*In making*
24 *awards under subparagraph (A), the Secretary*
25 *shall—*

1 “(i) make awards, as practicable, to
2 not fewer than five applicants; and

3 “(ii) ensure that information provided
4 through demonstration projects under this
5 paragraph is consistent with the best avail-
6 able medical information.

7 “(E) *REPORT TO CONGRESS.*—Not later
8 than 12 months after the date of the enactment
9 of this paragraph, and annually thereafter, the
10 Secretary shall submit to the Congress a report
11 that—

12 “(i) summarizes the activities of dem-
13 onstration projects under subparagraph (A);

14 “(ii) evaluates the extent to which the
15 projects were effective in increasing early
16 detection of gynecologic cancers and aware-
17 ness and knowledge of risk factors and early
18 warning signs in the populations to which
19 the projects were directed; and

20 “(iii) identifies barriers to early detec-
21 tion and appropriate treatment of such can-
22 cers.”.

23 (b) *CONFORMING AMENDMENT.*—Section
24 317P(d)(3)(A) of the Public Health Service Act (42 U.S.C.

- 2 *paragraph (5))” after “this section”.*
