A BILL

To direct the Secretary of Veterans Affairs to carry out the Women's Health Transition Training pilot program through at least fiscal year 2020, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Helping Expand and*
5 *Launch Transitional Health for Women Veterans Act” or*
6 *“HEALTH Act”.*

7 **SEC. 2. ENCOURAGEMENT OF PARTICIPATION IN WOMEN’S**

8 **HEALTH TRANSITION TRAINING PILOT PRO-**
9 **GRAM.**

10 (a) *DURATION.*—*The Secretary of Veterans Affairs*
11 *shall carry out the Women’s Health Transition Training*
12 *pilot program (in this section referred to as the “pilot pro-*
13 *gram”)* until at least September 30, 2020.

14 (b) *REPORT.*—*Not later than September 30, 2020, the*
15 *Secretary of Defense and the Secretary of Veterans Affairs*
16 *shall jointly submit to the appropriate congressional com-*
17 *mittees a report on the pilot program that includes the fol-*
18 *lowing:*

19 (1) *For the period since the commencement of the*
20 *pilot program—*

21 (A) *the number of women members by mili-*
22 *tary department (with respect to Department of*
23 *the Navy, separately for the Navy and Marine*
24 *Corps) who participated in the pilot program;*

1 (B) *the number of courses held under the*
2 *pilot program; and*

3 (C) *the locations at which such courses were*
4 *held, and the number of seats available and the*
5 *number of participants at each such location.*

6 (2) *With respect to the number of members who*
7 *participated in the pilot program as specified under*
8 *paragraph (1)—*

9 (A) *the number who enrolled in the health*
10 *care system established under section 1705(a) of*
11 *title 38, United States Code; and*

12 (B) *the number who attended at least one*
13 *health care appointment at a medical facility of*
14 *the Department of Veterans Affairs.*

15 (3) *Data relating to—*

16 (A) *satisfaction with courses held under the*
17 *pilot program;*

18 (B) *improved awareness of health care serv-*
19 *ices administered by the Secretary of Veterans*
20 *Affairs; and*

21 (C) *any other available statistics regarding*
22 *the pilot program.*

23 (4) *A discussion of regulatory, legal, or resource*
24 *barriers to—*

1 (A) making the pilot program permanent to
2 enable access by a greater number of women
3 members at locations throughout the United
4 States;

5 (B) offering the pilot program online for
6 women members who are unable to attend
7 courses held under the pilot program in person;
8 and

9 (C) the feasibility of automatically enrolling
10 pilot program participants in the health care
11 system established under section 1705(a) of title
12 38, United States Code.

13 (c) *APPROPRIATE CONGRESSIONAL COMMITTEES DE-*
14 *FINED.*—*In this section, the term “appropriate congres-*
15 *sional committees” means the Committees on Veterans’ Af-*
16 *fairs and the Committees on Armed Services of the House*
17 *of Representatives and the Senate.*
