## A BILL

To amend section 200303 of title 54, United States Code, to ensure that amounts are made available for projects to provide recreational public access, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Making Public Lands

5       Public Act”.

1     **SEC. 2. AVAILABILITY OF LAND AND WATER CONSERVA-**  
2                 **TION FUND FOR CERTAIN PUBLIC ACCESS**  
3                 **PROJECTS.**

4     (a) IN GENERAL.—Section 200303 of title 54, United  
5     States Code, is amended to read as follows:

6     **“§ 200303. Availability of funds for certain priority**  
7                 **projects**

8         “(a) IN GENERAL.—Notwithstanding any other pro-  
9     vision of this Act, the Secretary of the Interior and the  
10   Secretary of Agriculture shall ensure that, of the amounts  
11   appropriated for the fund for each fiscal year, not less  
12   than the greater of 3 percent of the amounts or  
13   \$20,000,000 shall be made available for projects identified  
14   on the priority list developed under subsection (b).

15         “(b) PRIORITY LIST.—The Secretary of the Interior  
16   and the Secretary of Agriculture, in consultation with the  
17   head of each affected Federal agency, shall annually de-  
18   velop a priority list for projects related to Federal land  
19   under the jurisdiction of the applicable Secretary.

20         “(c) CRITERIA.—Projects identified on the priority  
21   list developed under subsection (b) shall—

22                 “(1) maintain or increase public access to exist-  
23     ing Federal public land for hunting, fishing, or rec-  
24     reational shooting through acquisition of rights-of-  
25     way or acquisition of land (or any interest in land)

1       through equal value land exchanges from willing  
2       owners; or

3               “(2) enhance, maintain, or restore access on ex-  
4       isting roads, trails, or rights-of-way.”.

5       (b) CONFORMING AMENDMENTS.—

6               (1) LAND AND WATER CONSERVATION FUND  
7       ACT.—Chapter 2003 of title 54, United States Code,  
8       is amended—

9                       (A) in the first sentence of section 200308,  
10       by striking “by section 200303 of this title”;  
11       and

12                       (B) in the third sentence of section  
13       200309, by striking “by section 200303 of this  
14       title”.

15       (2) FEDERAL LAND TRANSACTION FACILITA-  
16       TION ACT.—Section 206(f)(2) of the Federal Land  
17       Transaction Facilitation Act (43 U.S.C. 2305(f)(2))  
18       is amended by striking “section 3 of the Land and  
19       Water Conservation Fund Act (16 U.S.C. 460l–6)”  
20       and inserting “chapter 2003 of title 54, United  
21       States Code”.
