## A BILL

To extend the Secure Rural Schools and Community Self-  
Determination Act of 2000.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF SECURE RURAL SCHOOLS AND**  
4 **COMMUNITY SELF-DETERMINATION ACT OF**  
5 **2000.**

6 (a) SECURE PAYMENTS FOR STATES AND COUNTIES  
7 CONTAINING FEDERAL LAND.—

1           (1) SECURE PAYMENTS.—Section 101 of the  
2       Secure Rural Schools and Community Self-Deter-  
3       mination Act of 2000 (16 U.S.C. 7111) is amended,  
4       in subsections (a) and (b), by striking “and 2018”  
5       each place it appears and inserting “2018, 2019,  
6       and 2020”.

7           (2) PAYMENTS TO STATES AND COUNTIES.—

8           (A) ELECTION TO RECEIVE PAYMENT  
9       AMOUNT.—Section 102(b) of the Secure Rural  
10      Schools and Community Self-Determination Act  
11      of 2000 (16 U.S.C. 7112(b)) is amended—

12           (i) in paragraph (1)(D)—

3           (B) EXPENDITURE RULES FOR ELIGIBLE  
4           COUNTIES.—Section 102(d) of the Secure Rural  
5           Schools and Community Self-Determination Act  
6           of 2000 (16 U.S.C. 7112(d)) is amended—

3                   (C) DISTRIBUTION OF PAYMENTS TO ELI-  
4                   GIBLE COUNTIES.—Section 103(d)(2) of the Se-  
5                   cure Rural Schools and Community Self-Deter-  
6                   mination Act of 2000 (16 U.S.C. 7113(d)(2)) is  
7                   amended by striking “through and for fiscal  
8                   years 2017 and 2018” and inserting “through  
9                   2015 and for each of fiscal years 2017 through  
10                  2020”.

11               (b) EXTENSION OF AUTHORITY TO CONDUCT SPE-  
12               CIAL PROJECTS ON FEDERAL LAND.—Section 208 of the  
13               Secure Rural Schools and Community Self-Determination  
14               Act of 2000 (16 U.S.C. 7128) is amended—

15                   (1) in subsection (a), by striking “2020” and  
16                   inserting “2022”; and

17                   (2) in subsection (b), by striking “2021” and  
18                   inserting “2023”.

19               (c) EXTENSION OF AUTHORITY TO EXPEND COUNTY  
20               FUNDS.—Section 304 of the Secure Rural Schools and  
21               Community Self-Determination Act of 2000 (16 U.S.C.  
22               7144) is amended—

23                   (1) in subsection (a), by striking “2020” and  
24                   inserting “2022”; and

1           (2) in subsection (b), by striking “2021” and  
2           inserting “2023”.
