Mr. BROOKS of Alabama (for himself, Ms. JENKINS of Kansas, Mr. FARENTHOLD, and Mr. SMITH of Texas) introduced the following bill; which was referred to the Committee on the Judiciary

## A BILL

To require the Director of U.S. Immigration and Customs Enforcement to submit annual reports regarding certain demographic information on aliens arrested.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Arrest Statistics Re-  
5 porting Act of 2015”.

6 **SEC. 2. REPORTING OF INFORMATION ON ARRESTEES.**

7 The Director of U.S. Immigration and Customs En-  
8 forcement shall, beginning on the date that is 1 year after  
9 the date of enactment of this Act, and annually thereafter,

1 publish and make publicly available on the Internet a re-  
2 port that includes, for each person arrested during the  
3 year preceding the date of the report and regarding whom  
4 a request was submitted to the Law Enforcement Support  
5 Center authorized under section 236(d) of the Immigra-  
6 tion and Nationality Act (8 U.S.C. 1226(d)) or any poten-  
7 tial matches forwarded under the information sharing pro-  
8 gram between the Department of Justice and the Depart-  
9 ment of Homeland Security (formerly known as “Secure  
10 Communities”), the following information, when available:

- 11 (1) The immigration status of the person.
- 12 (2) The nationality of the person.
- 13 (3) The offense for which the person was ar-  
14 rested, represented by the appropriate National  
15 Crime Information Center offense code.

16 **SEC. 3. REPORTING BY FBI DIRECTOR.**

17 The Director of the Federal Bureau of Investigation  
18 shall revise the Uniform Crime Reports to require that  
19 each report pertaining to an arrest shall include the infor-  
20 mation about the arrest published under section 2, and  
21 the Director shall also publish a summary of the data  
22 which shall include—

- 23 (1) a table containing the National Crime Infor-  
24 mation Center offense codes and the corresponding

1 occurrences for each immigration status category;  
2 and

3 (2) a table containing the National Crime Infor-  
4 mation Center offense codes and the corresponding  
5 occurrences for each nationality.

6 **SEC. 4. DEFINITIONS.**

7 In this Act:

8 (1) The term “immigration status” includes  
9 status as—

10 (A) a United States citizen or national;

11 (B) a lawful permanent resident of the  
12 United States;

13 (C) a nonimmigrant alien lawfully present  
14 in the United States; or

15 (D) an alien not lawfully present in the  
16 United States.

17 (2) The term “Uniform Crime Reports” means  
18 the reports authorized under section 534 of title 28,  
19 United States Code, and administered by the Fed-  
20 eral Bureau of Investigation which compiles nation-  
21 wide criminal statistics for use in law enforcement  
22 administration, operation, and management and to  
23 assess the nature and type of crime in the United  
24 States.
