3 **SECTION 1. SPECIAL WARFARE OPERATOR MASTER CHIEF**

4 **PETTY OFFICER (SEAL) LOUIS “LOU” J.**
5 **LANGLAIS POST OFFICE BUILDING.**

6 (a) DESIGNATION.—The facility of the United States
7 Postal Service located at 836 Anacapa Street, Santa Bar-
8 bara, California, shall be known and designated as the
9 “Special Warfare Operator Master Chief Petty Officer
10 (SEAL) Louis ‘Lou’ J. Langlais Post Office Building”.

11 (b) REFERENCES.—Any reference in a law, map, reg-
12 ulation, document, paper, or other record of the United
13 States to the facility referred to in subsection (a) shall
14 be deemed to be a reference to the “Special Warfare Oper-
15 ator Master Chief Petty Officer (SEAL) Louis ‘Lou’ J.
16 Langlais Post Office Building”.
