A BILL

- To facilitate the hosting in the United States of the 34th America's Cup by authorizing certain eligible vessels to participate in activities related to the competition.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "America's Cup Act5 of 2011".

1 SEC. 2. DEFINITIONS.

2 In this Act:

3 (1) 34TH AMERICA'S CUP.—The term "34th
4 America's Cup"—

5 (A) means the sailing competitions, com-6 mencing in 2011, to be held in the United 7 States in response to the challenge to the de-8 fending team from the United States, in accord-9 ance with the terms of the America's Cup gov-10 erning Deed of Gift, dated October 24, 1887; 11 and

(B) if a United States yacht club successfully defends the America's Cup, includes additional sailing competitions conducted by America's Cup Race Management during the 1-year
period beginning on the last date of such defense.

18 (2) AMERICA'S CUP RACE MANAGEMENT.—The
19 term "America's Cup Race Management" means the
20 entity established to provide for independent, profes21 sional, and neutral race management of the Amer22 ica's Cup sailing competitions.

23 (3) ELIGIBILITY CERTIFICATION.—The term
24 "Eligibility Certification" means a certification
25 issued under section 4.

1	(4) ELIGIBLE VESSEL.—The term "eligible ves-
2	sel" means a competing vessel or supporting vessel
3	of any registry that—
4	(A) is recognized by America's Cup Race
5	Management as an official competing vessel, or
6	supporting vessel of, the 34th America's Cup,
7	as evidenced in writing to the Administrator of
8	the Maritime Administration of the Department
9	of Transportation;
10	(B) transports not more than 25 individ-
11	uals, in addition to the crew;
12	(C) is not a ferry (as defined under section
13	2101(10b) of title 46, United States Code);
14	(D) does not transport individuals in point-
15	to-point service for hire; and
16	(E) does not transport merchandise be-
17	tween ports in the United States.
18	(5) SUPPORTING VESSEL.—The term "sup-
19	porting vessel" means a vessel that is operating in
20	support of the 34th America's Cup by—
21	(A) positioning a competing vessel on the
22	race course;
23	(B) transporting equipment and supplies
24	utilized for the staging, operations, or broadcast
25	of the competition; or

1	(C) transporting individuals who—
2	(i) have not purchased tickets or di-
3	rectly paid for their passage; and
4	(ii) who are engaged in the staging,
5	operations, or broadcast of the competi-
6	tion, race team personnel, members of the
7	media, or event sponsors.

8 SEC. 3. AUTHORIZATION OF ELIGIBLE VESSELS.

9 Notwithstanding sections 55102, 55103, and 55111 10 of title 46, United States Code, an eligible vessel, oper-11 ating only in preparation for, or in connection with, the 12 34th America's Cup competition, may position competing 13 vessels and may transport individuals and equipment and supplies utilized for the staging, operations, or broadcast 14 15 of the competition from and around the ports in the United States. 16

17 SEC. 4. CERTIFICATION.

(a) REQUIREMENT.—A vessel may not operate under
section 3 unless the vessel has received an Eligibility Certification.

(b) ISSUANCE.—The Administrator of the Maritime
Administration of the Department of Transportation is
authorized to issue an Eligibility Certification with respect
to any vessel that the Administrator determines, in his or

her sole discretion, meets the requirements set forth in
 section 2(4).

3 SEC. 5. ENFORCEMENT.

4 Notwithstanding sections 55102, 55103, and 55111
5 of title 46, United States Code, an Eligibility Certification
6 shall be conclusive evidence to the Secretary of the De7 partment of Homeland Security of the qualification of the
8 vessel for which it has been issued to participate in the
9 34th America's Cup as a competing vessel or a supporting
10 vessel.

11 SEC. 6. PENALTY.

12 Any vessel participating in the 34th America's Cup 13 as a competing vessel or supporting vessel that has not 14 received an Eligibility Certification or is not in compliance 15 with section 12112 of title 46, United States Code, shall 16 be subject to the applicable penalties provided in chapters 17 121 and 551 of title 46, United States Code.
