## A BILL

To amend titles XVIII and XIX of the Social Security Act with respect to the qualification of the director of food services of a Medicare skilled nursing facility or a Medicaid nursing facility.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safe Food for Seniors  
5 Act of 2015”.

1 **SEC. 2. QUALIFICATION OF DIRECTOR OF FOOD SERVICES**  
2 **OF A MEDICARE SKILLED NURSING FACILITY**  
3 **OR A MEDICAID NURSING FACILITY.**

4 (a) **MEDICARE SKILLED NURSING FACILITIES.**—Sec-  
5 tion 1819(b)(4)(A) of the Social Security Act (42 U.S.C.  
6 1395i–3(b)(4)(A)) is amended by adding at the end the  
7 following: “With respect to meeting any staffing require-  
8 ment imposed by the Secretary for purposes of satisfying  
9 clause (iv), in the case that the facility does not employ  
10 a full-time qualified dietitian (as defined in paragraph (2)  
11 of section 483.35(a) of title 42, Code of Federal Regula-  
12 tions, as in effect as of the date of the enactment of the  
13 Safe Food for Seniors Act of 2013) but complies with such  
14 section by designating a director of food services (as de-  
15 scribed in paragraph (1) of such section), the director of  
16 food services shall be a Certified Dietary Manager meeting  
17 the applicable requirements published by the Certifying  
18 Board for Dietary Managers, a Dietetic Technician, Reg-  
19 istered meeting the applicable requirements published by  
20 the Commission on Dietetic Registration, or an individual  
21 with equivalent military or academic qualifications (as  
22 specified by the Secretary).”.

23 (b) **MEDICAID NURSING FACILITIES.**—Section  
24 1919(b)(4)(A) of the Social Security Act (42 U.S.C.  
25 1396r(b)(4)(A)) is amended by adding at the end the fol-  
26 lowing: “With respect to meeting any staffing requirement

1 imposed by the Secretary for purposes of satisfying clause  
2 (iv), in the case that the facility does not employ a full-  
3 time qualified dietitian (as defined in paragraph (2) of sec-  
4 tion 483.35(a) of title 42, Code of Federal Regulations,  
5 as in effect as of the date of the enactment of the Safe  
6 Food for Seniors Act of 2013) but complies with such sec-  
7 tion by designating a director of food services (as de-  
8 scribed in paragraph (1) of such section), the director of  
9 food services shall be a Certified Dietary Manager meeting  
10 the applicable requirements published by the Certifying  
11 Board for Dietary Managers, a Dietetic Technician, Reg-  
12 istered meeting the applicable requirements published by  
13 the Commission on Dietetic Registration, or an individual  
14 with equivalent military or academic qualifications (as  
15 specified by the Secretary).”.

16 (c) EFFECTIVE DATE.—The amendments made by  
17 this section shall take effect on the date that is 180 days  
18 after the date of enactment of this Act.
