A BILL

To authorize the extension of nondiscriminatory treatment (normal trade relations treatment) to the products of Kazakhstan, Tajikistan, and Uzbekistan.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TERMINATION OF APPLICATION OF TITLE IV**
4 **OF THE TRADE ACT OF 1974 TO THE PROD-**
5 **UCTS OF KAZAKHSTAN.**

6 (a) PRESIDENTIAL DETERMINATIONS AND EXTEN-
7 SION OF NONDISCRIMINATORY TREATMENT.—Notwith-
8 standing any provision of title IV of the Trade Act of 1974
9 (19 U.S.C. 2431 et seq.), the President may—

1 (1) determine that the denial of nondiscrim-
2 inatory treatment should no longer apply to the
3 products of Kazakhstan; and

4 (2) after making a determination under para-
5 graph (1) with respect to Kazakhstan, proclaim the
6 extension of nondiscriminatory treatment (normal
7 trade relations treatment) to the products of
8 Kazakhstan.

9 (b) TERMINATION OF APPLICABILITY OF TITLE
10 IV.—On and after the date on which the President ex-
11 tends nondiscriminatory treatment to the products of
12 Kazakhstan pursuant to subsection (a), title IV of the
13 Trade Act of 1974 shall cease to apply to Kazakhstan.

14 **SEC. 2. TERMINATION OF APPLICATION OF TITLE IV OF**
15 **THE TRADE ACT OF 1974 TO THE PRODUCTS**
16 **OF TAJIKISTAN.**

17 (a) PRESIDENTIAL DETERMINATIONS AND EXTEN-
18 SION OF NONDISCRIMINATORY TREATMENT.—Notwith-
19 standing any provision of title IV of the Trade Act of 1974
20 (19 U.S.C. 2431 et seq.), the President may—

21 (1) determine that the denial of nondiscrim-
22 inatory treatment should no longer apply to the
23 products of Tajikistan; and

24 (2) after making a determination under para-
25 graph (1) with respect to Tajikistan, proclaim the

1 extension of nondiscriminatory treatment (normal
2 trade relations treatment) to the products of
3 Tajikistan.

4 (b) TERMINATION OF APPLICABILITY OF TITLE
5 IV.—On and after the date on which the President ex-
6 tends nondiscriminatory treatment to the products of
7 Tajikistan pursuant to subsection (a), title IV of the
8 Trade Act of 1974 shall cease to apply to Tajikistan.

9 **SEC. 3. TERMINATION OF APPLICATION OF TITLE IV OF**
10 **THE TRADE ACT OF 1974 TO THE PRODUCTS**
11 **OF UZBEKISTAN.**

12 (a) PRESIDENTIAL DETERMINATIONS AND EXTEN-
13 SION OF NONDISCRIMINATORY TREATMENT.—Notwith-
14 standing any provision of title IV of the Trade Act of 1974
15 (19 U.S.C. 2431 et seq.), the President may—

16 (1) determine that the denial of nondiscrim-
17 inatory treatment should no longer apply to the
18 products of Uzbekistan; and

19 (2) after making a determination under para-
20 graph (1) with respect to Uzbekistan, proclaim the
21 extension of nondiscriminatory treatment (normal
22 trade relations treatment) to the products of Uzbek-
23 istan.

24 (b) TERMINATION OF APPLICABILITY OF TITLE
25 IV.—On and after the date on which the President ex-

- 1 tends nondiscriminatory treatment to the products of Uz-
- 2 bekistan pursuant to subsection (a), title IV of the Trade
- 3 Act of 1974 shall cease to apply to Uzbekistan.
