A BILL

To establish a grant program to enhance existing secondary education programs for the purpose of teaching high school students about the Constitution of the United States and the constitutions of the individual States.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Constitution and Citi-
- 5 zenship Day Act of 2009".

1 SEC. 2. CONSTITUTION DAY AND CIVIC RESPONSIBILITY

- 2 SYSTEM FOR STUDENTS.
- 3 Part C of title II of the Elementary and Secondary
- 4 Education Act of 1965 (20 U.S.C. 6601 et seq.) is amend-
- 5 ed by adding at the end the following new subpart:
- 6 "Subpart 6—Teaching of the Constitution
- 7 "SEC. 2371. ESTABLISHMENT AND OPERATION OF CON-
- 8 STITUTION DAY GRANT PROGRAM.
- 9 "(a) Grant Program Authorized.—The Secretary
- 10 shall establish and implement a grant program, to be
- 11 known as the 'Constitution Day Grant Program', under
- 12 which the Secretary shall award grants on a competitive
- 13 basis to local educational agencies and charter schools for
- 14 the purposes of enhancing educational programs to teach
- 15 students about the United States Constitution and the
- 16 constitution of the State in which the grant recipient is
- 17 located.
- 18 "(b) Grantee Eligibility Requirements.—
- 19 Grants under this section may only be awarded to a local
- 20 educational agency or charter school with established sec-
- 21 ondary educational programs to teach students about the
- 22 United States Constitution and the constitution of the
- 23 State in which the grant recipient is located.
- 24 "(c) Operation of Educational Programs.—An
- 25 educational program funded by a grant under this section
- 26 shall—

- 1 "(1) occur on Constitution Day, September 17,
- 2 of each calender year (or on the Monday imme-
- diately following Constitution Day, if Constitution
- 4 Day falls on a Saturday or a Sunday);
- 5 "(2) include assemblies, discussions, presen-
- 6 tations, or events commemorating the Constitution
- 7 of the United States and the constitution of the
- 8 State in which the grant recipient is located;
- 9 "(3) include efforts to reinforce existing Con-
- stitutional curricula conducted by the grant recipi-
- ent; and
- 12 "(4) make available to eligible students partici-
- pating in such program the ability to register to
- vote.
- 15 "(d) Voter Registration Laws.—A grant recipi-
- 16 ent under this section shall abide by all applicable State
- 17 and Federal voter registration laws.
- 18 "SEC. 2372. GRANT APPLICATION PROCESS.
- 19 "(a) Secretary Created Process.—The Sec-
- 20 retary shall develop an application process for the grant
- 21 program under this subpart, consistent with the require-
- 22 ments of this section.
- 23 "(b) Grant Application Requirements.—An ap-
- 24 plication for a grant under this subpart shall—

1	"(1) describe the educational activities to be
2	funded by the grant; and
3	"(2) provide assurances that the requirements
4	of section 2371(c) will be met, and any additional
5	assurances that the Secretary determines to be nec-
6	essary to ensure compliance with the requirements
7	of this subpart.

8 "SEC. 2373. AUTHORIZATION OF APPROPRIATIONS.

9 "There is authorized to be appropriated to the Sec-10 retary \$4,000,000 for each of fiscal years 2010 through 11 2014 to carry out this subpart.".
