# **A BILL**

To amend title XVIII of the Social Security Act to provide for coverage of certain lymphedema compression treatment items under the Medicare program.

1        *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Lymphedema Treatment*  
 5 *Act”.*

6 **SEC. 2. MEDICARE COVERAGE OF CERTAIN LYMPHEDEMA**  
 7 **COMPRESSION TREATMENT ITEMS.**

8        *(a) COVERAGE.—*

9            *(1) IN GENERAL.—Section 1861 of the Social Se-*  
 10 *curity Act (42 U.S.C. 1395x) is amended—*

11            *(A) in subsection (s)(2)—*

12            *(i) in subparagraph (GG), by striking*  
 13 *“and” after the semicolon at the end;*

14            *(ii) in subparagraph (HH), by strik-*  
 15 *ing the period at the end and inserting “;*  
 16 *and”;* and

17            *(iii) by adding at the end the following*  
 18 *new subparagraph:*

19            *“(II) lymphedema compression treatment items*  
 20 *(as defined in subsection (ll));”;* and

21            *(B) by adding at the end the following new*  
 22 *subsection:*

23            *“(ll) LYMPHEDEMA COMPRESSION TREATMENT*  
 24 *ITEMS.—The term ‘lymphedema compression treatment*  
 25 *items’ means standard and custom fitted gradient compres-*

1 *sion garments and other items determined by the Secretary*  
 2 *that are—*

3           “(1) *furnished on or after January 1, 2024, to*  
 4 *an individual with a diagnosis of lymphedema for the*  
 5 *treatment of such condition;*

6           “(2) *primarily and customarily used to serve a*  
 7 *medical purpose and for the treatment of*  
 8 *lymphedema, as determined by the Secretary; and*

9           “(3) *prescribed by a physician (or a physician*  
 10 *assistant, nurse practitioner, or a clinical nurse spe-*  
 11 *cialist (as those terms are defined in section*  
 12 *1861(aa)(5)) to the extent authorized under State*  
 13 *law).”.*

14           (2) *PAYMENT.—*

15           (A) *IN GENERAL.—Section 1833(a)(1) of the*  
 16 *Social Security Act (42 U.S.C. 1395l(a)(1)) is*  
 17 *amended—*

18                   (i) *by striking “and” before “(DD)”;*

19                   *and*

20                   (ii) *by inserting before the semicolon at*  
 21 *the end the following: “and (EE) with re-*  
 22 *spect to lymphedema compression treatment*  
 23 *items (as defined in section 1861(lll)), the*  
 24 *amount paid shall be equal to 80 percent of*  
 25 *the lesser of the actual charge or the amount*

1                   *determined under the payment basis deter-*  
2                   *mined under section 1834(z)”.*

3                   *(B) PAYMENT BASIS AND LIMITATIONS.—*

4                   *Section 1834 of the Social Security Act (42*  
5                   *U.S.C. 1395m) is amended by adding at the end*  
6                   *the following new subsection:*

7                   *“(z) PAYMENT FOR LYMPHEDEMA COMPRESSION*  
8                   *TREATMENT ITEMS.—*

9                   *“(1) IN GENERAL.—The Secretary shall deter-*  
10                  *mine an appropriate payment basis for lymphedema*  
11                  *compression treatment items (as defined in section*  
12                  *1861(lll)). In making such a determination, the Sec-*  
13                  *retary may take into account payment rates for such*  
14                  *items under State plans (or waivers of such plans)*  
15                  *under title XIX, the Veterans Health Administration,*  
16                  *and group health plans and health insurance coverage*  
17                  *(as such terms are defined in section 2791 of the Pub-*  
18                  *lic Health Service Act), and such other information*  
19                  *as the Secretary determines appropriate.*

20                  *“(2) FREQUENCY LIMITATION.—No payment*  
21                  *may be made under this part for lymphedema com-*  
22                  *pression treatment items furnished other than at such*  
23                  *frequency as the Secretary may establish.*

24                  *“(3) APPLICATION OF COMPETITIVE ACQUISSI-*  
25                  *TION.—In the case of lymphedema compression treat-*

1 *ment items that are included in a competitive acqui-*  
2 *sition program in a competitive acquisition area*  
3 *under section 1847(a)—*

4 *“(A) the payment basis under this sub-*  
5 *section for such items furnished in such area*  
6 *shall be the payment basis determined under*  
7 *such competitive acquisition program; and*

8 *“(B) the Secretary may use information on*  
9 *the payment determined under such competitive*  
10 *acquisition programs to adjust the payment*  
11 *amount otherwise determined under this sub-*  
12 *section for an area that is not a competitive ac-*  
13 *quisition area under section 1847, and in the*  
14 *case of such adjustment, paragraphs (8) and (9)*  
15 *of section 1842(b) shall not be applied.”.*

16 (3) *CONFORMING AMENDMENT.—Section*  
17 *1847(a)(2) of the Social Security Act (42 U.S.C.*  
18 *1395w-3(a)(2)) is amended by adding at the end the*  
19 *following new subparagraph:*

20 *“(D) LYMPHEDEMA COMPRESSION TREAT-*  
21 *MENT ITEMS.—Lymphedema compression treat-*  
22 *ment items (as defined in section 1861(III)) for*  
23 *which payment would otherwise be made under*  
24 *section 1834(z).”.*



1           **(b) INCLUSION IN REQUIREMENTS FOR SUPPLIERS OF**  
2 **MEDICAL EQUIPMENT AND SUPPLIES.**—Section 1834 of the  
3 *Social Security Act (42 U.S.C. 1395m) is amended—*

4           (1) *in subsection (a)(20)(D), by adding at the*  
5 *end the following new clause:*

6                           *“(iv) Lymphedema compression treat-*  
7                           *ment items (as defined in section*  
8                           *1861(III)).”.*

9           (2) *in subsection (j)(5)—*

10                           *(A) by redesignating subparagraphs (E)*  
11 *and (F) as subparagraphs (F) and (G), respec-*  
12 *tively; and*

13                           *(B) by inserting after subparagraph (D) the*  
14 *following new subparagraph:*

15                           *“(E) lymphedema compression treatment*  
16 *items (as defined in section 1861(III));”.*
