A BILL

To amend the Elementary and Secondary Education Act of 1965 and the Omnibus Crime Control and Safe Streets Act of 1968 to require silent alarms in elementary schools and secondary schools, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Alyssa’s Legacy Youth
3 in Schools Safety Alert Act” or the “ALYSSA Act”.

4 **SEC. 2. REQUIRING SILENT ALARMS IN SCHOOLS.**

5 (a) LOCAL EDUCATIONAL AGENCY PLANS.—Section
6 1112(c) of the Elementary and Secondary Education Act
7 of 1965 (20 U.S.C. 6312(c)) is amended by adding at the
8 end the following:

9 “(8) ensure that each school served by the local
10 educational agency is prepared to address a school
11 security emergency, including the use of panic
12 alarms which are not audible within the school build-
13 ing to adequately alert local law enforcement au-
14 thorities and emergency responders about a safety
15 issue at the school.”.

16 (b) CONDITION OF RECEIPT OF FUNDS.—Subpart 2
17 of part F of title VIII of the Elementary and Secondary
18 Education Act of 1965 (20 U.S.C. 7901 et seq.) is amend-
19 ed by adding at the end the following:

20 **“SEC. 8549D. SCHOOL SECURITY.**

21 “(a) IN GENERAL.—As a condition of receipt of
22 funds under this Act, each local educational agency shall
23 ensure that each elementary school and secondary school
24 served by such local educational agency is equipped with
25 at least one panic alarm for use in a school security emer-

1 gency (including a non-fire evacuation, lockdown, or active
2 shooter situation).

3 “(b) PANIC ALARM DEFINED.—For purposes of this
4 section and section 1112(c)(8), the term ‘panic alarm’
5 means a silent security system signal generated by the
6 manual activation of a device intended to signal a life-
7 threatening or emergency situation requiring a response
8 from law enforcement.”.

9 **SEC. 3. FUNDING FOR SCHOOL RESOURCE OFFICERS.**

10 Section 1101(a)(11) of the Omnibus Crime Control
11 and Safe Streets Act of 1968 (34 U.S.C. 10261(a)(11))
12 is amended—

13 (1) in subparagraph (A), by striking
14 “\$1,047,119,000 for each of fiscal years 2006
15 through 2009” and inserting “\$1,097,119,000 for
16 each of fiscal years 2021 through 2030”; and

17 (2) in subparagraph (B), by inserting after “of
18 the purposes of part Q” the following: “, and not
19 less than \$50,000,000 shall be allocated for grants
20 pursuant to applications submitted by units of local
21 government or law enforcement agencies for the pur-
22 poses described in section 1701(b)(12)”.
