Mr. McCAUL introduced the following bill; which was referred to the
Committee on the Judiciary

A BILL

To direct the Secretary of State to submit to Congress a report on the designation of Iran’s Islamic Revolutionary Guard Corps as a foreign terrorist organization, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “IRGC Terrorist Des-
5 ignation Act”.

1 **SEC. 2. REPORT ON DESIGNATION OF IRAN'S ISLAMIC REV-**
2 **OLUTIONARY GUARD CORPS AS A FOREIGN**
3 **TERRORIST ORGANIZATION.**

4 (a) SENSE OF CONGRESS.—It is the sense of Con-
5 gress that—

6 (1) Iran's Islamic Revolutionary Guard Corps
7 meets the criteria for designation as a foreign ter-
8 rorist organization as set forth in section 219 of the
9 Immigration and Nationality Act (8 U.S.C. 1189);
10 and

11 (2) the Secretary of State should so designate
12 Iran's Islamic Revolutionary Guard Corps as a for-
13 eign terrorist organization under such section 219.

14 (b) REPORT.—

15 (1) REPORT REQUIRED.—Not later than 30
16 days after the date of the enactment of this Act, the
17 Secretary of State, in consultation with the Director
18 of National Intelligence, shall submit to the appro-
19 priate committees of Congress—

20 (A) a detailed report on whether Iran's Is-
21 lamic Revolutionary Guard Corps meets the cri-
22 teria for designation as a foreign terrorist orga-
23 nization as set forth in section 219 of the Im-
24 migration and Nationality Act (8 U.S.C. 1189);
25 and

1 (B) if the Secretary determines that Iran’s
2 Islamic Revolutionary Guard Corps does not
3 meet the criteria set forth under such section
4 219, a detailed justification as to which criteria
5 have not been met.

6 (2) FORM.—The report required by paragraph
7 (1) shall—

8 (A) be submitted in unclassified form, but
9 may include a classified annex; and

10 (B) be made available only in electronic
11 form and shall not be printed, except if a print-
12 ed copy is requested by an office of the legisla-
13 tive branch.

14 (3) APPROPRIATE COMMITTEES OF CONGRESS
15 DEFINED.—In this subsection, the term “appro-
16 priate committees of Congress” means—

17 (A) the Committee on Armed Services, the
18 Committee on Banking, Housing, and Urban
19 Affairs, the Committee on Foreign Relations,
20 the Committee on the Judiciary, the Committee
21 on Homeland Security and Governmental Af-
22 fairs, and the Select Committee on Intelligence
23 of the Senate; and

24 (B) the Committee on Armed Services, the
25 Committee on Financial Services, the Com-

1 mittee on Foreign Affairs, the Committee on
2 the Judiciary, the Committee on Homeland Se-
3 curity, and the Permanent Select Committee on
4 Intelligence of the House of Representatives.
