## A BILL

To increase language access to behavioral health services at eligible health centers, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Mental Health Work-  
5       force and Language Access Act of 2023”.

6       **SEC. 2. DEMONSTRATION PROGRAM TO INCREASE LAN-**  
7                   **GUAGE ACCESS AT ELIGIBLE HEALTH CEN-**  
8                   **TERS.**

9       (a) GRANTS.—The Secretary shall carry out a dem-  
10      onstration program consisting of awarding grants to eligi-

1     ble health centers to recruit, hire, employ, and supervise  
2     qualified behavioral health professionals who—

3                 (1) are proficient in speaking and under-  
4                 standing both spoken English and at least one other  
5                 spoken language, including any necessary specialized  
6                 vocabulary, terminology, and phraseology;

7                 (2) are able to effectively, accurately, and im-  
8                 partially communicate directly with limited English  
9                 proficient individuals in their primary language; and

10                 (3) are, or will be, employed—

11                         (A) directly by the eligible health center; or  
12                         (B) through a contract between the eligible  
13                 health center and the qualified behavioral  
14                 health professional under which such profes-  
15                 sional provides services as part of the eligible  
16                 health center's workforce or under supervision  
17                 by the health center, in order to provide behav-  
18                 ioral health services in another language.

19                 (b) PREFERENCE.—In selecting grant recipients  
20     under subsection (a), the Secretary shall give preference  
21     to eligible health centers at which at least 10 percent of  
22     the patients are best served in a language other than  
23     English, as indicated by data in the Uniform Data System  
24     of the Health Resources and Services Administration (or  
25     any successor database).

1       (c) OUTREACH.—An eligible health center receiving  
2 a grant under this section shall use a portion of the grant  
3 funds to disseminate information about the behavioral  
4 health services supported through the grant.

5       (d) REPORTS.—

6              (1) INITIAL REPORT.—Not later than 6 months  
7 after the first grants are awarded under subsection  
8 (a), the Secretary shall submit to the Committee on  
9 Appropriations and the Committee on Energy and  
10 Commerce of the House of Representatives, the  
11 Committee on Appropriations and the Committee on  
12 Health, Education, Labor, and Pensions of the Sen-  
13 ate, and other appropriate congressional committees,  
14 a report on the implementation of the program  
15 under this section. Such report shall include—

16                  (A) the languages spoken by the qualified  
17 behavioral health professionals recruited pursu-  
18 ant to a grant under subsection (a);

19                  (B) the eligible health center at which each  
20 such professional was placed;

21                  (C) how many eligible health centers re-  
22 ceived grants under subsection (a);

23                  (D) an analysis, conducted in consultation  
24 with the eligible health centers receiving grants  
25 under subsection (a), of the effectiveness of

1           such grants at increasing language access to be-  
2           havioral health services; and

3           (E) best practices, developed in consulta-  
4           tion with eligible health centers receiving grants  
5           under subsection (a), for the recruitment and  
6           retention of qualified behavioral health profes-  
7           sionals at such health centers.

8           (2) FINAL REPORT.—Not later than the end of  
9           fiscal year 2026, the Secretary shall submit to the  
10          Committee on Appropriations and the Committee on  
11          Energy and Commerce of the House of Representa-  
12          tives, the Committee on Appropriations and the  
13          Committee on Health, Education, Labor, and Pen-  
14          sions of the Senate, and other appropriate congres-  
15          sional committees, a final report on the implemen-  
16          tation of the program under this section, including the  
17          information, analysis, and best practices described in  
18          subparagraphs (A) through (E) of paragraph (1).

19           (e) DEFINITIONS.—In this section:

20           (1) The term “eligible health center” means a  
21          health center (as defined in section 330 of the Pub-  
22          lic Health Service Act (42 U.S.C. 254b)) that is al-  
23          ready receiving assistance pursuant to one or more  
24          grants under such section 330 at the time of the

1 award to such health center of a supplemental grant  
2 under subsection (a).

3 (2) The term “qualified behavioral health pro-  
4 fessional” means—

5 (A) a behavioral and mental health profes-  
6 sional (as defined in section 331(a)(3)(E)(i) of  
7 the Public Health Service Act (42 U.S.C.  
8 254d(a)(3)(E)(i)));

9 (B) a substance use disorder counselor;

10 (C) an occupational therapist; or

11 (D) an individual who—

12 (i) has not yet been licensed or cer-  
13 tified to serve as a professional listed in  
14 any of subparagraphs (A) through (C);  
15 and

16 (ii) will serve at the eligible health  
17 center under the supervision of a licensed  
18 individual or certified professional so list-  
19 ed.

20 (3) The term “Secretary” means the Secretary  
21 of Health and Human Services.

22 (f) FUNDING.—Subject to the availability of appro-  
23 priations, out of amounts otherwise appropriated under  
24 section 760(g) of the Public Health Service Act (42 U.S.C.  
25 294k(g)), the Secretary is authorized to use up to

- 1 \$10,000,000 for each of fiscal years 2024 through 2029
- 2 to carry out this section.

○
