## A BILL

To amend the Older Americans Act of 1965 to authorize appropriations for fiscal years 2014 through 2018.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Older Americans Act  
5 Reauthorization of 2014”.

6 **SEC. 2. AMENDMENTS.**

7 (a) AUTHORIZATION OF APPROPRIATIONS.—Section  
8 216 of the Older Americans Act of 1965 (42 U.S.C.  
9 3020f) is amended by striking “2007, 2008, 2009, 2010,

1 and 2011” each place it appears and inserting “2014,  
2 2015, 2016, 2017, and 2018”.

3 (b) AUTHORIZATION OF APPROPRIATIONS FOR  
4 GRANTS FOR STATE AND COMMUNITY PROGRAMS ON  
5 AGING.—The Older Americans Act of 1965 (42 U.S.C.  
6 3023)—

7 (1) in section 303—

8 (A) in subsections (a), (b), and (d) by  
9 striking “2007, 2008, 2009, 2010, and 2011”  
10 each place it appears and inserting “2014,  
11 2015, 2016, 2017, and 2018”, and

12 (B) in subsection (e)—

13 (i) by striking paragraph (1),

14 (ii) in paragraph (2) by striking  
15 “\$166,500,000” and all that follows  
16 through “2011”, and inserting  
17 “\$187,000,000 for each of the fiscal years  
18 2014, 2015, 2016, 2017, and 2018”, and

19 (iii) by redesignating paragraphs (2)  
20 and (3) as paragraphs (1) and (2), respec-  
21 tively, and

22 (2) in section 373(f)(1)(A) is amended by strik-  
23 ing “2007, 2008, 2009, 2010, and 2011” and in-  
24 serting “2014, 2015, 2016, 2017, and 2018”.

1           (c) AUTHORIZATION OF APPROPRIATIONS FOR EDU-  
2   CATIONAL ACTIVITIES.—Section 411(b) of the Older  
3   Americans Act of 1965 (42 U.S.C. 3032(b)) is amended  
4   by striking “2007, 2008, 2009, 2010, and 2011” and in-  
5   serting “2014, 2015, 2016, 2017, and 2018”.

6           (d) AUTHORIZATION OF APPROPRIATIONS FOR COM-  
7   MUNITY SERVICE EMPLOYMENT.—Section 517(a) of the  
8   Older Americans Act of 1965 (42 U.S.C. 3056o) is  
9   amended by striking “2007, 2008, 2009, 2010, and 2011”  
10   and inserting “2014, 2015, 2016, 2017, and 2018”.

11          (e) AUTHORIZATION OF APPROPRIATIONS FOR  
12   GRANTS FOR NATIVE AMERICANS.—Section 643 of the  
13   Older Americans Act of 1965 (42 U.S.C. 3057n) is  
14   amended—

15           (1) in paragraph (1) by striking “2007” and in-  
16           serting “2014”, and

17           (2) by amending paragraph (2) to read as fol-  
18           lows:

19           “(2) for part C, \$7,900,000 for each of the fis-  
20           cal years 2015, 2016, 2017, and 2018.”.
