A BILL

To direct the Secretary of Defense and the Secretary of Veterans Affairs to jointly conduct a study on the incidence of breast cancer among members of the Armed Forces and veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Armed Forces Breast
- 5 Cancer Research Act".

1	SEC. 2. STUDY ON BREAST CANCER AMONG MEMBERS OF
2	THE ARMED FORCES AND VETERANS.
3	(a) STUDY.—The Secretary of Defense and the Sec-
4	retary of Veterans Affairs shall jointly conduct a study
5	on the incidence of breast cancer among members of the
6	Armed Forces (including members of the National Guard
7	and Reserve components) and veterans. Such study shall
8	include the following:
9	(1) A determination of the number of the mem-
10	bers and veterans diagnosed with breast cancer.
11	(2) A determination of demographic informa-
12	tion regarding such members and veterans, includ-
13	ing—
14	(A) race;
15	(B) ethnicity;
16	(C) sex;
17	(D) age;
18	(E) possible exposure to hazardous ele-
19	ments or chemical or biological agents (includ-
20	ing any vaccines) and where such exposure oc-
21	curred;
22	(F) the locations of duty stations that such
23	member or veteran was assigned;
24	(G) the locations in which such member or
25	veteran was deployed; and

1	(H) the geographic area of residence prior
2	to deployment.
3	(3) An analysis of breast cancer treatments re-
4	ceived by such members and veterans.
5	(4) Other information the Secretaries consider
6	necessary.
7	(b) Report.—Not later than 18 months after the
8	date of the enactment of this Act, the Secretary of Defense
9	and the Secretary of Veterans Affairs shall jointly submit
10	to Congress a report containing the results of the study
11	required under subsection (a).
