# **A BILL**

To amend title 38, United States Code, to improve the methods by which the Secretary of Veterans Affairs conducts oversight of certain educational institutions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Isakson-Roe Education*  
5 *Oversight Expansion Act”.*

6 **SEC. 2. EXPANSION OF DEPARTMENT OF VETERANS AF-**  
7 **FAIRS OVERSIGHT OF CERTAIN EDU-**  
8 **CATIONAL INSTITUTIONS.**

9 *(a) ADDITIONAL REQUIREMENT FOR APPROVAL.—Sec-*  
10 *tion 3675(b) of title 38, United States Code, is amended*  
11 *by adding at the end the following new paragraph:*

12 *“(5) The educational institution agrees to, not*  
13 *later than 30 days after any date on which such edu-*  
14 *cational institution becomes subject to an action or*  
15 *event described in section 3673(e)(3) of this title, sub-*  
16 *mit to the State approving agency, or the Secretary*  
17 *when acting in the role of a State approving agency,*  
18 *a notification of such action or event in such form*  
19 *and containing such information as the Secretary de-*  
20 *termines appropriate.”.*

21 *(b) ADDITIONAL REQUIREMENT FOR APPROVAL OF*  
22 *NONACCREDITED COURSES.—*

23 *(1) IN GENERAL.—Section 3676(c) of such title*  
24 *is amended—*

1           (A) by redesignating paragraphs (14)  
2 through (16) as paragraphs (15) through (17),  
3 respectively; and

4           (B) by inserting after paragraph (13) the  
5 following new paragraph:

6           “(14) The institution agrees to, not later than 30  
7 days after any date on which such institution becomes  
8 subject to an action or event described in section  
9 3673(e)(3) of this title, submit to the State approving  
10 agency, or the Secretary when acting in the role of a  
11 State approving agency, a notification of such action  
12 or event in such form and containing such informa-  
13 tion as the Secretary determines appropriate.”.

14           (2) CONFORMING AMENDMENTS.—Such title is  
15 further amended—

16           (A) in section 3672(b)(2)(C), by striking  
17 “paragraph (14) or (15)” and inserting “para-  
18 graph (15) or (16)”;

19           (B) in section 3675(b)(3), by striking “(14),  
20 (15), and (16)” and inserting “(15), (16), and  
21 (17)”;

22           (C) in section 3679(d), by striking “de-  
23 scribed in paragraph (14) or (15)” and inserting  
24 “described in paragraph (15) or (16)”;

1                   (D) in section 3680A(a)(4)(C)(iii), by strik-  
2                   ing “section 3676(c)(14) and (15)” and inserting  
3                   “section 3676(c)(15) and (16)”.

4           (c) *ADDITIONAL GROUNDS FOR SUSPENSION OF AP-*  
5 *PROVAL.*—Section 3679(f)(1) of such title is amended by  
6 *adding at the end the following new subparagraph:*

7                   “(I) Comply with the notification requirements  
8                   under sections 3675(b)(5) and 3676(c)(14) of this  
9                   title, when applicable.”.

10           (d) *DEADLINE FOR RISK-BASED SURVEYS DATA-*  
11 *BASE.*—The Secretary of Veterans Affairs shall establish the  
12 *database required under section 3673A(c) of title 38, United*  
13 *States Code, by not later than 180 days after the date of*  
14 *the enactment of this Act.*
