A BILL

To amend the Small Business Act with respect to the procurement program for women-owned small business concerns, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Women’s Procurement
5 Program Improvement Act of 2012”.

6 **SEC. 2. PROCUREMENT PROGRAM FOR WOMEN-OWNED**
7 **SMALL BUSINESS CONCERNS.**

8 Section 8(m) of the Small Business Act (15 U.S.C.
9 637(m)) is amended—

10 (1) in paragraph (2)—

11 (A) by striking subparagraph (D);

12 (B) by redesignating subparagraph (E) as
13 subparagraph (D) respectively; and

14 (C) by striking subparagraph (F), and in-
15 serting the following:

16 “(E) each of the concerns—

17 “(i) is certified by a Federal agency,
18 a State government, or a national certi-
19 fying entity approved by the Adminis-
20 trator, as a small business concern owned
21 and controlled by women; or

22 “(ii) is certified by the Administrator
23 as a small business concern owned and
24 controlled by women.”;

1 (2) in paragraph (3), by striking “subpara-
2 graph (2)(A)” inserting the following: “paragraph
3 (2)(A) or paragraph (7)(A)”;

4 (3) in paragraph (5) by striking “under para-
5 graph (2)(F)” each place it appears and inserting
6 “under paragraph (2)(E)”;

7 (4) by adding at the end the following:

8 “(7) SOLE SOURCE CONTRACTS FOR ECONOMI-
9 CALLY DISADVANTAGED WOMEN-OWNED SMALL
10 BUSINESSES.—In accordance with this section, a
11 contracting officer may award a sole source contract
12 to any small business concern meeting the require-
13 ments of section 8(m)(2)(A) of this Act if—

14 “(A) such concern is determined to be a
15 responsible contract with respect to perform-
16 ance of such contract opportunity and the con-
17 tracting officer does not have a reasonable ex-
18 pectation that 2 or more businesses meeting the
19 requirements of section 8(m)(2)(A) will submit
20 offers;

21 “(B) the anticipated award price of the
22 contract (including options) will not exceed—

23 “(i) \$6,500,000 in the case of a con-
24 tract opportunity assigned a standard in-
25 dustrial code for manufacturing; or

1 “(ii) \$4,000,000 in the case of any
2 other contract opportunity; and

3 “(C) in the estimation of the contracting
4 officer, the contract award can be made at a
5 fair and reasonable price.

6 “(8) SOLE SOURCE CONTRACTS FOR WOMEN-
7 OWNED SMALL BUSINESSES IN SUBSTANTIALLY
8 UNDERREPRESENTED INDUSTRIES.—In accordance
9 with this section, a contracting officer may award a
10 sole source contract to any small business concerns
11 meeting the requirements of section 8(m)(3) of this
12 Act if—

13 “(A) such concern is determined to be a
14 responsible contract with respect to perform-
15 ance of such contract opportunity and the con-
16 tracting officer does not have a reasonable ex-
17 pectation that 2 or more businesses meeting the
18 requirements of section 8(m)(3) will submit of-
19 fers;

20 “(B) the anticipated award price of the
21 contract (including options) will not exceed—

22 “(i) \$6,500,000 in the case of a con-
23 tract opportunity assigned a standard in-
24 dustrial code for manufacturing; or

1 “(ii) \$4,000,000 in the case of any
2 other contract opportunity; and

3 “(C) in the estimation of the contracting
4 officer, the contract award can be made at a
5 fair and reasonable price.”.
