A BILL

To promote veteran involvement in STEM education, computer science, and scientific research, and for other purposes.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. SHORT TITLE. 4 This Act may be cited as the "Supporting Veterans in STEM Careers Act". SEC. 2. DEFINITIONS. 7 In this Act: 8 (1) Director.—The term "Director" means 9 the Director of the National Science Foundation. 10 FOUNDATION.—The term "Foundation" 11 means the National Science Foundation. 12 (3) STEM.—The term "STEM" has the mean-13 ing given the term in section 2 of the America COM-PETES Reauthorization Act of 2010 (42 U.S.C. 14 15 6621 note). (4) Veteran.—The term "veteran" has the 16 17 meaning given the term in section 101 of title 38, 18 United States Code. 19 SEC. 3. SUPPORTING VETERANS IN STEM EDUCATION AND 20 COMPUTER SCIENCE. 21 (a) Supporting Veteran Involvement in Sci-ENTIFIC RESEARCH AND STEM EDUCATION.—The Director shall, through the research and education activities

of the Foundation, encourage veterans to study and pur-

- 1 sue careers in STEM and computer science, in coordina-
- 2 tion with other Federal agencies that serve veterans.
- 3 (b) Veteran Outreach Plan.—Not later than 90
- 4 days after the date of enactment of this Act, the Director
- 5 shall submit to the Committee on Science, Space, and
- 6 Technology of the House of Representatives and the Com-
- 7 mittee on Commerce, Science, and Transportation of the
- 8 Senate a plan for how the Foundation can enhance its out-
- 9 reach efforts to veterans. Such plan shall—
- 10 (1) report on the Foundation's existing out-
- 11 reach activities;
- 12 (2) identify the best method for the Foundation
- to leverage existing authorities and programs to fa-
- 14 cilitate and support veterans in STEM careers and
- studies, including teaching programs; and
- 16 (3) identify a method for the Foundation to
- 17 track veteran participation in research and edu-
- 18 cation programs of the Foundation, and describe
- any barriers to collecting such information.
- 20 (c) National Science Board Indicators Re-
- 21 PORT.—The National Science Board shall provide in its
- 22 annual report on indicators of the state of science and en-
- 23 gineering in the United States any available and relevant
- 24 data on veterans in science and engineering careers or
- 25 education programs.

9	erans" before the period at the end.
10	(f) NATIONAL SCIENCE FOUNDATION COMPUTER
11	AND NETWORK SECURITY CAPACITY BUILDING GRANTS
12	UPDATE.—Section 5(a) of the Cyber Security Research
13	and Development Act of 2002 (15 U.S.C. 7404(a)) is
14	amended—
15	(1) in paragraph (1), by inserting "and stu-
16	dents who are veterans" after "these fields"; and
17	(2) in paragraph (3)—
18	(A) in subparagraph (I), by striking "and"
19	at the end;
20	(B) by redesignating subparagraph (J) as
21	subparagraph (K); and
22	(C) by inserting after subparagraph (I) the
23	following:

1	"(J) creating opportunities for veterans to
2	transition to careers in computer and network
3	security; and".
4	(g) Graduate Traineeships in Computer and
5	NETWORK SECURITY RESEARCH UPDATE.—Section
6	5(c)(6)(C) of the Cyber Security Research and Develop-
7	ment Act of 2002 (15 U.S.C. 7404(c)(6)(C)) is amended
8	by inserting "or veterans," after "disciplines".
9	(h) Veterans and Military Families STEM
10	EDUCATION INTERAGENCY SUBCOMMITTEE.—
11	(1) In general.—The Director of the Office of
12	Science and Technology Policy shall establish a sub-
13	committee under the Committee on STEM Edu-
14	cation of the National Science and Technology
15	Council (established under section 101 of the Amer-
16	ica COMPETES Reauthorization Act of 2010) to
17	coordinate Federal programs and policies for
18	transitioning and training veterans and military
19	spouses for STEM careers.
20	(2) Duties of subcommittee.—The sub-
21	committee established under paragraph (1) shall—
22	(A) coordinate Federal agency STEM out-
23	reach activities and programs for veterans and
24	military spouses; and

1	(B) develop and facilitate the implementa-
2	tion by participating agencies of a strategic
3	plan, which shall—
4	(i) specify and prioritize short- and
5	long-term objectives;
6	(ii) specify the common metrics that
7	will be used by Federal agencies to assess
8	progress toward achieving such objectives;
9	(iii) identify barriers veterans face in
10	reentering the workforce, including a lack
11	of formal STEM education, career guid-
12	ance, and the process of transferring mili-
13	tary credits and skills to college credits;
14	(iv) identify barriers military spouses
15	face in establishing careers in STEM
16	fields;
17	(v) describe the approaches that each
18	participating agency will take to address
19	administratively the barriers described in
20	clauses (iii) and (iv); and
21	(vi) identify any barriers that require
22	Federal or State legislative or regulatory
23	changes in order to be addressed.
24	(3) Duties of OSTP.—The Director of the Of-
25	fice of Science and Technology Policy shall encour-

1	age and monitor the efforts of the Federal agencies
2	participating in the subcommittee to ensure that the
3	strategic plan required under paragraph (2)(B) is
4	developed and executed effectively and that the ob-
5	jectives of such strategic plan are met.

- (4) Report.—The Director of the Office of Science and Technology Policy shall—
 - (A) not later than 1 year after the date of enactment of this Act, submit to Congress the strategic plan required under paragraph (2)(B); and
- (B) include in the annual report required by section 101(d) of the America COMPETES Reauthorization Act a description of any progress made in carrying out the activities described in paragraph (2)(B) of this subsection.
