## A BILL

To amend the Carl D. Perkins Career and Technical Education Act of 2006 to require reporting by the Secretary of Education on requests for funding research that were not granted and had the greatest potential for improving career and technical education, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Missed Opportunities  
5 in Career and Technical Education Act of 2017”.

1 **SEC. 2. ANNUAL REPORTING ON MISSED OPPORTUNITIES.**

2 Part A of title III of the Carl D. Perkins Career and  
3 Technical Education Act of 2006 (20 U.S.C. 2391 et seq.)  
4 is amended by adding at the end the following:

5 **“SEC. 319. ANNUAL REPORTING ON MISSED OPPORTUNI-**  
6 **TIES.**

7 “(a) IN GENERAL.—Not later than the last day of  
8 the first fiscal quarter following the end of each fiscal  
9 year, the Secretary shall submit a report to Congress—

10 “(1) identifying—

11 “(A) the total number of requests that  
12 were under review during such fiscal year by  
13 any office, agency, institute, or center of the  
14 Department of Education for funding, in whole  
15 or in part, career and technical education pro-  
16 grams; and

17 “(B) of such total number—

18 “(i) the number of such requests that  
19 were granted;

20 “(ii) the number of such requests that  
21 were denied; and

22 “(iii) the number of such requests  
23 that remained pending at the end of the  
24 fiscal year; and

25 “(2) with respect to the requests described in  
26 clauses (ii) and (iii) of paragraph (1)(B), identifying

1 the requests with the greatest potential for improv-  
2 ing career and technical education.

3 “(b) TRADE SECRETS AND CONFIDENTIAL INFORMA-  
4 TION.—This section does not authorize the Secretary to  
5 disclose any information that is a trade secret or confiden-  
6 tial information subject to section 552(b)(4) of title 5,  
7 United States Code, or section 1905 of title 18, United  
8 States Code.”.
