AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2024, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	That the following sums are appropriated, out of any
2	money in the Treasury not otherwise appropriated, for the
3	Legislative Branch for the fiscal year ending September
4	30, 2024, and for other purposes, namely:

7	HOUSE OF REPRESENTATIVES
8	Salaries and Expenses
9	For salaries and expenses of the House of Represent-
10	atives, \$1,850,998,000, as follows:
11	House Leadership Offices
12	For salaries and expenses, as authorized by law,
13	\$36,560,000, including: Office of the Speaker,
14	\$10,499,000, including $$35,000$ for official expenses of
15	the Speaker; Office of the Majority Floor Leader,
16	\$3,730,000, including $$15,000$ for official expenses of the
17	Majority Leader; Office of the Minority Floor Leader,
18	\$10,499,000, including $$17,500$ for official expenses of

- 7 DEFICIT REDUCTION OR TO REDUCE THE FEDERAL
- 8 DEBT
- 9 Sec. 110. (a) Notwithstanding any other provision
- 10 of law, any amounts appropriated under this Act for
- 11 "HOUSE OF REPRESENTATIVES—SALARIES AND
- 12 Expenses—members' representational allow-
- 13 ANCES" shall be available only for fiscal year 2024. Any
- 14 amount remaining after all payments are made under such
- 15 allowances for fiscal year 2024 shall be deposited in the
- 16 Treasury and used for deficit reduction (or, if there is no
- 17 Federal budget deficit after all such payments have been
- 18 made, for reducing the Federal debt, in such manner as
- 19 the Secretary of the Treasury considers appropriate).
- 20 (b) The Committee on House Administration of the

1	LIMITATION ON AMOUNT AVAILABLE TO LEASE VEHICLES
2	SEC. 111. None of the funds made available in this
3	Act may be used by the Chief Administrative Officer of
4	the House of Representatives to make any payments from
5	any Members' Representational Allowance for the leasing
6	of a vehicle, excluding mobile district offices, in an aggre-
7	gate amount that exceeds \$1,000 for the vehicle in any
8	month.
9	CYBERSECURITY ASSISTANCE FOR HOUSE OF
10	REPRESENTATIVES
11	SEC. 112. The head of any Federal entity that pro-
12	vides assistance to the House of Representatives in the
13	House's efforts to deter, prevent, mitigate, or remediate
14	cybersecurity risks to, and incidents involving, the infor-
15	mation systems of the House shall take all necessary steps
16	to ensure the constitutional integrity of the separate
17	branches of the government at all stages of providing the
18	assistance, including applying minimization procedures to
19	limit the spread or sharing of privileged House and Mem-
20	ber information.

22	For Joint Committees, as follows:

1	JOINT ECONOMIC COMMITTEE
2	For salaries and expenses of the Joint Economic
3	Committee, \$4,283,000, to be disbursed by the Secretary
4	of the Senate.
5	JOINT COMMITTEE ON TAXATION
6	For salaries and expenses of the Joint Committee on
7	Taxation, \$13,059,000, to be disbursed by the Chief Ad-
8	ministrative Officer of the House of Representatives.
9	For other joint items, as follows:
10	Office of the Attending Physician
11	For medical supplies, equipment, and contingent ex-
12	penses of the emergency rooms, and for the Attending
13	Physician and their assistants, including:
14	(1) an allowance of \$3,500 per month to the

12	Salaries and Expenses
13	For salaries and expenses of the Office of Congres-
14	sional Accessibility Services, \$1,766,000, to be disbursed
15	by the Secretary of the Senate.
16	CAPITOL POLICE
17	Salaries
18	For salaries of employees of the Capitol Police, in-
19	cluding overtime, hazardous duty pay, and Government
20	contributions for health, retirement, social security, pro-
21	fessional liability insurance, and other applicable employee
22	benefits, \$588,070,000 of which overtime shall not exceed
23	\$74,976,000 unless the Committees on Appropriations of
24	the House and Senate are notified, to be disbursed by the
25	Chief of the Capitol Police or a duly authorized designee:

- 1 Provided, That of the total amount appropriated,
- 2 \$15,000,000 shall be available for retention bonuses.
- 3 General Expenses
- 4 For necessary expenses of the Capitol Police, includ-
- 5 ing motor vehicles, communications and other equipment,
- 6 security equipment and installation, uniforms, weapons,
- 7 supplies, materials, training, medical services, forensic
- 8 services, stenographic services, personal and professional
- 9 services, the employee assistance program, the awards pro-
- 10 gram, postage, communication services, travel advances,
- 11 relocation of instructor and liaison personnel for the Fed-
- 12 eral Law Enforcement Training Centers, and not more
- 13 than \$7,500 to be expended on the certification of the
- 14 Chief of the Capitol Police in connection with official rep-
- 15 resentation and reception expenses, \$192,846,000, to be
- 16 disbursed by the Chief of the Capitol Police or a duly au-
- 17 thorized designee: *Provided*, That, notwithstanding any
- 18 other provision of law, the cost of basic training for the
- 19 Capitol Police at the Federal Law Enforcement Training
- 20 Centers for fiscal year 2024 shall be paid by the Secretary
- 21 of Homeland Security from funds available to the Depart-
- 22 ment of Homeland Security.

3	Salaries and Expenses
4	For salaries and expenses necessary for the operation
5	of the Office of Congressional Workplace Rights
6	\$8,000,000, of which \$2,500,000 shall remain available
7	until September 30, 2025, and of which not more than
8	\$1,000 may be expended on the certification of the Execu-
9	tive Director in connection with official representation and
10	reception expenses.
11	CONGRESSIONAL BUDGET OFFICE
12	Salaries and Expenses
13	For salaries and expenses necessary for operation of
14	the Congressional Budget Office, including not more than
15	\$6,000 to be expended on the certification of the Director
16	of the Congressional Budget Office in connection with offi-
17	cial representation and reception expenses, \$64,637,000
18	Provided, That the Director shall use not less than
19	\$500,000 of the amount made available under this head-
20	ing for (1) improving technical systems, processes, and
21	models for the purpose of improving the transparency of
22	estimates of budgetary effects to Members of Congress
23	employees of Members of Congress, and the public, and
24	(2) to increase the availability of models, economic as-

- 4 CAPITAL CONSTRUCTION AND OPERATIONS
- 5 For salaries for the Architect of the Capitol, and
- 6 other personal services, at rates of pay provided by law;
- 7 for all necessary expenses for surveys and studies, con-
- 8 struction, operation, and general and administrative sup-
- 9 port in connection with facilities and activities under the
- 10 care of the Architect of the Capitol including the Botanic
- 11 Garden; Senate and House office buildings, and other fa-
- 12 cilities under the jurisdiction of the Architect of the Cap-
- 13 itol; including furnishings and office equipment; including
- 14 not more than \$5,000 for official reception and represen-
- 15 tation expenses, to be expended as the Architect of the
- 16 Capitol may approve; for purchase or exchange, mainte-
- 17 nance, and operation of a passenger motor vehicle,
- 18 \$149,073,000, of which \$3,200,000 shall remain available
- 19 until September 30, 2028.
- 20 CAPITOL BUILDING
- 21 For all necessary expenses for the maintenance, care
- 22 and operation of the Capitol, \$74,304,000, of which
- 23 \$42,599,000 shall remain available until September 30,
- 24 2028.

1	Capitol Grounds
2	For all necessary expenses for care and improvement
3	of grounds surrounding the Capitol, the Senate and House
4	office buildings, and the Capitol Power Plant,
5	\$16,365,000, of which $$2,000,000$ shall remain available
6	until September 30, 2028.
7	House Office Buildings
8	For all necessary expenses for the maintenance, care
9	and operation of the House office buildings,
10	\$168,439,000, of which \$53,140,000 shall remain avail-
11	able until September 30, 2028, and of which \$41,800,000
12	shall remain available until expended for the restoration
13	and renovation of the Cannon House Office Building.
14	Capitol Power Plant
15	For all necessary expenses for the maintenance, care
16	and operation of the Capitol Power Plant; and all elec-
17	trical substations of the Capitol; lighting, heating, power
18	(including the purchase of electrical energy) and water
19	and sewer services for the Capitol, Senate and House of-
20	fice buildings, Library of Congress buildings, and the
21	grounds about the same, Botanic Garden, Senate garage,
22	and air conditioning refrigeration not supplied from plants

17	For all necessary expenses for the operation of the
18	Capitol Visitor Center, \$27,692,000.
19	Administrative Provisions
20	NO BONUSES FOR CONTRACTORS BEHIND SCHEDULE OR
21	OVER BUDGET
22	SEC. 113. None of the funds made available in this
23	Act for the Architect of the Capitol may be used to make
24	incentive or award payments to contractors for work or
25	contracts or programs for which the contractor is behind

- 1 schedule or over budget, unless the Architect of the Cap-
- 2 itol, or agency-employed designee, determines that any
- 3 such deviations are due to unforeseeable events, govern-
- 4 ment-driven scope changes, or are not significant within
- 5 the overall scope of the project and/or program.

6 LIBRARY OF CONGRESS

7 Salaries and Expenses

- 8 For all necessary expenses of the Library of Congress
- 9 not otherwise provided for, including development and
- 10 maintenance of the Library's catalogs; custody and custo-

- 10 States Code: *Provided*, That the Copyright Office may not
- 11 obligate or expend any funds derived from collections
