# **A BILL**

To authorize the Secretary of the Interior to acquire land in Frederick County, Maryland, for the Historic Preservation Training Center of the National Park Service, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Frederick Jobs and His-*  
5 *toric Preservation Training Center Land Acquisition Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *CENTER.*—*The term “Center” means the*  
9 *Historic Preservation Training Center and related fa-*  
10 *cilities of the National Park Service in Frederick*  
11 *County, Maryland.*

12 (2) *SECRETARY.*—*The term “Secretary” means*  
13 *the Secretary of the Interior, acting through the Di-*  
14 *rector of the National Park Service.*

15 **SEC. 3. ACQUISITION OF LAND FOR ADMINISTRATIVE PUR-**  
16 **POSES OF HISTORIC PRESERVATION TRAIN-**  
17 **ING CENTER.**

18 (a) *IN GENERAL.*—*To further develop the Center in ac-*  
19 *cordance with section 305306 of title 54, United States*  
20 *Code, the Secretary may acquire not more than 20 acres*  
21 *of land or interests in land in Frederick County, Maryland,*  
22 *for the Center for the purpose of supporting the physical*  
23 *space, program initiatives, and workforce development ca-*  
24 *capacity of the Center.*

1       **(b) METHOD OF ACQUISITION.**—*Land or an interest*  
2 *in land for the Center may only be acquired under sub-*  
3 *section (a) by donation, transfer, exchange, or purchase*  
4 *from a willing seller using donated or appropriated funds.*

5       **(c) ADMINISTRATION OF ACQUIRED LAND.**—*On acqui-*  
6 *sition of land or an interest in land for the Center under*  
7 *subsection (a), the acquired land or interest in land shall*  
8 *be administered by the Secretary for the purpose described*  
9 *in subsection (a).*
