A BILL

To deem the Step 2 compliance date for standards of performance for new residential wood heaters, new residential hydronic heaters, and forced-air furnaces to be May 15, 2023.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Relief from New
5 Source Performance Standards Act of 2017”.

6 **SEC. 2. STEP 2 COMPLIANCE DATE FOR STANDARDS OF**
7 **PERFORMANCE FOR NEW RESIDENTIAL**
8 **WOOD HEATERS, NEW RESIDENTIAL**
9 **HYDRONIC HEATERS, AND FORCED-AIR FUR-**
10 **NACES.**

11 (a) IN GENERAL.—The Step 2 compliance date (as
12 such term is used in the final rule entitled “Standards
13 of Performance for New Residential Wood Heaters, New
14 Residential Hydronic Heaters and Forced-Air Furnaces”
15 published at 80 Fed. Reg. 13672 (March 16, 2015)) is
16 deemed to be May 15, 2023

17 (b) CONFORMING CHANGES.—Not later than 60 days
18 after the date of enactment of this Act, the Administrator
19 of the Environmental Protection Agency shall make such
20 technical and conforming changes to rules and guidance
21 documents as may be necessary to implement subsection
22 (a).
