To amend the Small Business Act to require a report on 7(a) agents, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "7(a) Loan Agent Over-3 sight Act".

#### 4 SEC. 2. REPORT ON 7(a) AGENTS.
