A BILL

To provide for disadvantaged business enterprise supportive services programs at modal administrations of the Department of Transportation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disadvantaged Busi-
5 ness Enterprise Supportive Services Expansion Act”.

1 **SEC. 2. INCREASE CAP FOR FEDERAL HIGHWAY ADMINIS-**
2 **TRATION DISADVANTAGED BUSINESS ENTER-**
3 **PRISE SUPPORTIVE SERVICES PROGRAM.**

4 (a) IN GENERAL.—Section 140(c) of title 23, United
5 States Code, is amended, in the second sentence, by strik-
6 ing “\$10,000,000” and inserting “\$25,000,000”.

7 (b) CONFORMING AMENDMENT.—Section 104(a)(1)
8 of title 23, United States Code, is amended by striking
9 subparagraphs (C) through (E) and inserting the fol-
10 lowing:

11 “(C) \$525,799,671 for fiscal year 2024;

12 “(D) \$536,015,664 for fiscal year 2025;

13 and

14 “(E) \$546,435,977 for fiscal year 2026.”.

15 (c) EFFECTIVE DATE.—The amendments made by
16 this section shall take effect on October 1, 2023.

17 **SEC. 3. FEDERAL TRANSIT ADMINISTRATION DISADVAN-**
18 **TAGED BUSINESS ENTERPRISE SUPPORTIVE**
19 **SERVICES PROGRAM.**

20 (a) IN GENERAL.—Section 5332 of title 49, United
21 States Code, is amended by adding at the end the fol-
22 lowing:

23 “(g) DISADVANTAGED BUSINESS ENTERPRISE SUP-
24 PORTIVE SERVICES PROGRAM.—

25 “(1) IN GENERAL.—The Secretary, in coordina-
26 tion with the Administrator of the Federal Transit

1 Administration, the Associate Administrator for Civil
2 Rights of the Federal Transit Administration, other
3 Federal agencies, State agencies, authorities, asso-
4 ciations, institutions, Tribal governments, for profit
5 or nonprofit corporations, and any other organiza-
6 tions or persons, including transit authorities and
7 transit-specific organizations, may develop, conduct,
8 and administer training programs and assistance
9 programs in connection with any program under this
10 chapter so that small business concerns owned and
11 controlled by socially and economically disadvan-
12 taged individuals may achieve proficiency to com-
13 pete, on an equal basis, for contracts and sub-
14 contracts.

15 “(2) FUNDING.—Of the amounts made avail-
16 able to carry out section 5314, the Secretary, in co-
17 ordination with the Administrator of the Federal
18 Transit Administration, the Associate Administrator
19 for Civil Rights of the Federal Transit Administra-
20 tion, shall use not more than \$5,000,000 for each
21 fiscal year to carry out this subsection.

22 “(3) NONAPPLICABILITY OF CERTAIN PROVI-
23 SIONS.—Notwithstanding section 3106 of title 41,
24 section 6101 of that title shall not be applicable to

1 contracts and agreements entered into pursuant to
2 paragraph (1).”.

3 (b) FUNDING.—Section 5338(a) of title 49, United
4 States Code, is amended—

5 (1) in paragraph (1), by striking subparagraphs
6 (C), (D), and (E) and inserting the following:

7 “(C) \$13,995,000,000 for fiscal year 2024;

8 “(D) \$14,284,000,000 for fiscal year
9 2025; and

10 “(E) \$14,647,000,000 for fiscal year
11 2026.”; and

12 (2) in paragraph (2)(H), by striking
13 “\$12,404,500 for fiscal year 2024, \$12,660,748 for
14 fiscal year 2025, and \$12,982,608 for fiscal year
15 2026” and inserting “\$17,404,500 for fiscal year
16 2024, \$17,660,748 for fiscal year 2025, and
17 \$17,982,608 for fiscal year 2026”.

18 (c) EFFECTIVE DATE.—The amendments made by
19 this section shall take effect on October 1, 2023.

1 **SEC. 4. FEDERAL AVIATION ADMINISTRATION SOCIALLY**
2 **AND ECONOMICALLY DISADVANTAGED BUSI-**
3 **NESS PARTICIPATION SUPPORTIVE SERVICES**
4 **PROGRAM.**

5 (a) IN GENERAL.—Section 47113 of title 49, United
6 States Code, is amended by adding at the end the fol-
7 lowing:

8 “(f) SOCIALLY AND ECONOMICALLY DISADVANTAGED
9 BUSINESS PARTICIPATION SUPPORTIVE SERVICES PRO-
10 GRAM.—

11 “(1) IN GENERAL.—The Secretary, in coordina-
12 tion with the Assistant Administrator of the Office
13 of Civil Rights of the Federal Aviation Administra-
14 tion, may make agreements to provide assistance to
15 an eligible entity described in paragraph (2) to de-
16 velop, conduct, and administer training programs
17 and assistance programs in connection with any
18 project to be carried out under a grant agreement
19 under this subchapter in order that small business
20 concerns owned and controlled by socially and eco-
21 nomically disadvantaged individuals may achieve
22 proficiency to compete, on an equal basis, for con-
23 tracts and subcontracts related to such projects, and
24 for Small Business Innovation Research contracts.

1 “(2) ELIGIBLE ENTITIES DESCRIBED.—An eli-
2 gible entity described in this paragraph is any of the
3 following:

4 “(A) A State or territory.

5 “(B) A political subdivision of a State or
6 local government.

7 “(C) A Tribal government.

8 “(D) A special purpose district or public
9 authority with an aviation function.

10 “(E) A port authority.

11 “(F) A metropolitan planning organization.

12 “(G) A group of entities described in any
13 of subparagraphs (A) through (F).

14 “(H) Any other profit or non-profit organi-
15 zation or group of organizations deemed appro-
16 priate by the Secretary.

17 “(3) FUNDING.—From amounts available in the
18 Airport and Airways Trust Fund established under
19 section 9502 of the Internal Revenue Code of 1986,
20 the Secretary, in cooperation with the Assistant Ad-
21 ministrator of the Office of Civil Rights of the Fed-
22 eral Aviation Administration, may use such sums as
23 necessary, not to exceed \$5,000,000 per fiscal year,
24 for the administration of this subsection.”.

1 (b) EXPENDITURE AUTHORITY FROM AIRPORT AND
2 AIRWAY TRUST FUND.—Section 9502(d)(1)(A) of the In-
3 ternal Revenue Code of 1986 is amended by inserting “or
4 section 47113(f) of title 49, United States Code” before
5 the semicolon at the end.

6 (c) EFFECTIVE DATE.—The amendments made by
7 this section shall take effect on October 1, 2023.
