## A BILL

To amend title 10, United States Code, to provide for a review of the characterization or terms of discharge from the Armed Forces of individuals with mental health disorders alleged to affect terms of discharge.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fairness for Veterans  
5 Act of 2016”.

1 **SEC. 2. REVIEW OF CHARACTERIZATION OR TERMS OF DIS-**  
2 **CHARGE FROM THE ARMED FORCES OF INDI-**  
3 **VIDUALS WITH MENTAL HEALTH DISORDERS**  
4 **ALLEGED TO AFFECT TERMS OF DISCHARGE.**

5 Section 1553(d) of title 10, United States Code, is  
6 amended by adding at the end the following new para-  
7 graph:

8 “(3)(A) In addition to the requirements of para-  
9 graphs (1) and (2), in the case of a former member de-  
10 scribed in subparagraph (B), the board shall—

11 “(i) review medical evidence of the Secretary of  
12 Veterans Affairs or a civilian health care provider  
13 that is presented by the former member; and

14 “(ii) review the case with a rebuttable presump-  
15 tion in favor of the former member that post-trau-  
16 matic stress disorder or traumatic brain injury ma-  
17 terially contributed to the circumstances resulting in  
18 the discharge of a lesser characterization.

19 “(B) A former member described in this subpara-  
20 graph is a former member described in paragraph (1) or  
21 a former member whose application for relief is based in  
22 whole or in part on matters relating to post-traumatic  
23 stress disorder or traumatic brain injury as supporting ra-  
24 tionale or as justification for priority consideration whose  
25 post-traumatic stress disorder or traumatic brain injury

1 is related to combat or military sexual trauma, as deter-  
2 mined by the Secretary concerned.”.
