3 SECTION 1. SHORT TITLE; FINDINGS.

- 4 (a) SHORT TITLE.—This Act may be cited as the
- 5 "Rota Cultural and Natural Resources Study Act".
- 6 (b) FINDINGS.—Congress finds as follows:

| 5 | (2) The island of Rota has been described by |
| 6 | professional archeologists as having the most numer- |
| 7 | ous, most intact, and generally the most unique pre- |
| 8 | historic sites of any of the islands of the Mariana |
| 9 | Archipelago. |
| 10 | (3) The island of Rota contains remaining ex- |
| 11 | amples of what is known as the Latte Phase of the |
| 12 | cultural tradition of the indigenous Chamorro people |
| 13 | of the Mariana Islands. Latte stone houses are rem- |
| 14 | nants of the ancient Chamorro culture. |
| 15 | (4) Four prehistoric sites are listed on the Na- |
| 16 | tional Register of Historic Places: Monchon Archeo- |
| 17 | logical District (also known locally as Monchon |
| 18 | Latte Stone Village), Taga Latte Stone Quarry, the |
| 19 | Dugi Archeological Site that contains, latte stone |
| 20 | structures, and the Chugai Pictograph Cave that |
| 21 | contains examples of ancient Chamorro rock art. |
| 22 | Alaguan Bay Ancient Village is another latte stone |
| 23 | prehistoric site that is surrounded by tall-canopy |
| 24 | limestone forest. |

| 1 | (5) In addition to prehistoric sites, the island of |

| 2 | Rota boasts historic sites remaining from the Japa- |
| 3 | nese period (1914–1945). Several of these sites are |
| 4 | on the National Register of Historic Places: Nanyo |
| 5 | Kohatsu Kabushiki Kaisha Sugar Mill, Japanese |
| 6 | Coastal Defense Gun, and the Japanese Hospital. |
| 7 | (6) The island of Rota's natural resources are |
| 8 | significant because of the extent and intact condition |
| 9 | of its native limestone forest that provides habitat |
| 10 | for several federally endangered listed species, the |
| 11 | Mariana crow, and the Rota bridled white-eye birds, |
| 12 | that are also native to the island of Rota. Three en- |
| 13 | dangered plant species are also found on Rota and |
| 14 | two are endemic to the island. |
| 15 | (7) Because of the significant cultural and nat- |
| 16 | ural resources listed above, on September 2005, the |
| 17 | National Park Service, Pacific West Region, com- |
| 18 | pleted a preliminary resource assessment on the is- |
| 19 | land of Rota, Commonwealth of the Northern Mar- |
| 20 | iana Islands, which determined that the "establish- |
| 21 | ment of a unit of the national park system |
| 22 | appear[ed] to be the best way to ensure the long |
| 23 | term protection of Rota's most important cultural |
| 24 | resources and its best examples of its native lime- |
| 25 | stone forest.". |
