# **A BILL**

To amend the Homeland Security Act of 2002 to protect U.S. Customs and Border Protection officers, agents, other personnel, and canines against potential synthetic opioid exposure, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Synthetic Opioid Expo-  
5 sure Prevention and Training Act”.

6 **SEC. 2. PROTECTION AGAINST POTENTIAL SYNTHETIC**  
7                   **OPIOID EXPOSURE WITHIN U.S. CUSTOMS**  
8                   **AND BORDER PROTECTION.**

9       (a) IN GENERAL.—Subtitle B of title IV of the  
10 Homeland Security Act of 2002 (6 U.S.C. 211 et seq.)  
11 is amended by inserting after section 415 the following  
12 new section:

13 **“SEC. 416. PROTECTION AGAINST POTENTIAL SYNTHETIC**  
14                   **OPIOID EXPOSURE.**

15       “(a) IN GENERAL.—The Commissioner of U.S. Cus-  
16 toms and Border Protection shall issue a policy that speci-  
17 fies effective protocols and procedures for the safe han-  
18 dling of potential synthetic opioids, including fentanyl, by  
19 U.S. Customs and Border Protection officers, agents,  
20 other personnel, and canines, and to reduce the risk of  
21 injury or death resulting from accidental exposure and en-  
22 hance post-exposure management.

23       “(b) TRAINING.—

24               “(1) IN GENERAL.—Together with the issuance  
25       of the policy described in subsection (a), the Com-

1       missioner of U.S. Customs and Border Protection  
2       shall require mandatory and recurrent training on  
3       the following:

4               “(A) The potential risk of opioid exposure  
5               and safe handling procedures for potential syn-  
6               thetic opioids, including precautionary measures  
7               such as the use of personal protective equip-  
8               ment during such handling.

9               “(B) How to access and administer opioid  
10              receptor antagonists, including naloxone, post-  
11              exposure to potential synthetic opioids.

12             “(2) INTEGRATION.—The training described in  
13             paragraph (1) may be integrated into existing train-  
14             ing under section 411(l) for U.S. Customs and Bor-  
15             der Protection officers, agents, and other personnel.

16             “(c) PERSONAL PROTECTIVE EQUIPMENT AND  
17             OPIOID RECEPTOR ANTAGONISTS.—Together with the  
18             issuance of the policy described in subsection (a), the  
19             Commissioner of U.S. Customs and Border Protection  
20             shall ensure the availability of personal protective equip-  
21             ment and opioid receptor antagonists, including naloxone,  
22             to all U.S. Customs and Border Protection officers,  
23             agents, other personnel, and canines at risk of accidental  
24             exposure to synthetic opioids.

1       “(d) OVERSIGHT.—To ensure effectiveness of the pol-  
2 icy described in subsection (a)—

3               “(1) the Commissioner of U.S. Customs and  
4 Border Protection shall regularly monitor the effi-  
5 cacy of the implementation of such policy and adjust  
6 protocols and procedures, as necessary; and

7               “(2) the Inspector General of the Department  
8 shall audit compliance with the requirements of this  
9 section not less than once each year for the five  
10 years after the date of the enactment of this sec-  
11 tion.”.

12       (b) CLERICAL AMENDMENT.—The table of contents  
13 in section 1(b) of the Homeland Security Act of 2002 is  
14 amended by inserting after the item relating to section  
15 415 the following new item:

“Sec. 416. Protection against potential synthetic opioid exposure.”.
