A BILL

To require the Secretary of the Treasury to carry out a study on Chinese support for Afghan illicit finance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Exposing China’s Sup-*
5 *port for the Taliban Act”.*

6 **SEC. 2. STUDY ON CHINESE SUPPORT FOR AFGHAN ILLICIT**

7 **FINANCE.**

8 *(a) FINDINGS.—Congress finds the following:*

9 *(1) Though China and Afghanistan share only a*
10 *small land border, when it comes to illicit financial*
11 *activity between the two countries, China has a dem-*
12 *onstrated history of permissiveness regarding traf-*
13 *ficking and money laundering that could support both*
14 *the Taliban and its associates.*

15 *(2) A 2014 Financial Action Task Force report*
16 *titled, “Financial Flows Linked to the Production*
17 *and Trafficking of Afghan Opiates” found evidence of*
18 *import/export companies registered in China that*
19 *were transferring funds to Afghanistan, likely as part*
20 *of trade-based money laundering schemes centered*
21 *around illicit opium production and trafficking,*
22 *which, per the United Nations Office on Drugs and*
23 *Crime (UNODC), is one of the Taliban’s main sources*
24 *of income.*

1 (3) *Since the U.S. withdrawal from Afghanistan*
2 *in August 2021, China has announced its willingness*
3 *to lend financial support and legitimacy to the*
4 *Taliban-led government in Afghanistan, including Af-*
5 *ghan Interior Minister, Sirajuddin Haqqani, a mem-*
6 *ber of the U.S.-sanctions designated Foreign Terrorist*
7 *Organization, the Haqqani Network.*

8 (4) *China's permissive policies regarding Afghan*
9 *illicit finance run counter to the strategic interests of*
10 *the United States with respect to countering traf-*
11 *ficking and preventing terrorist groups from accessing*
12 *the international financial system.*

13 (5) *China's role as a critical source of financial*
14 *wherewithal for the Taliban and its associates to*
15 *process and implement drug and other illicit-activity*
16 *transactions warrants further study as these actions*
17 *pose a threat both to the safety and security of the*
18 *people of Afghanistan and the international commu-*
19 *nity.*

20 (6) *Congress needs to better understand how*
21 *China could leverage its relationships and resources*
22 *within Afghanistan and how these activities could di-*
23 *rectly or indirectly provide financial support to ter-*
24 *rorist organizations, including the Taliban and its*
25 *associates.*

1 **(b) STUDY.**—

2 **(1) REQUIREMENT.**—*Not later than one year*
3 *after the date of the enactment of this Act, the Sec-*
4 *retary of the Treasury shall provide to the Committee*
5 *on Financial Services of the House of Representatives*
6 *and the Committee on Banking, Housing, and Urban*
7 *Affairs of the Senate a report on the financial activi-*
8 *ties of the Government of China and Chinese entities*
9 *in connection with the finances of Afghanistan and*
10 *the Taliban.*

11 **(2) MATTERS INCLUDED.**—*The report under*
12 *paragraph (1) shall include the following:*

13 **(A)** *An assessment of the activities under-*
14 *taken by the Government of China and Chinese-*
15 *registered companies to support illicit financial*
16 *networks in Afghanistan, particularly such net-*
17 *works involved in narcotics trafficking, illicit fi-*
18 *nancial transactions, official corruption, natural*
19 *resources exploitation, and terrorist networks.*

20 **(B)** *An assessment of financial, commercial,*
21 *and economic activities undertaken by the Gov-*
22 *ernment of China and Chinese companies in Af-*
23 *ghanistan to support Chinese policies counter to*
24 *American strategic interests.*

1 (C) *Any recommendations to Congress re-*
2 *garding legislative or regulatory improvements*
3 *necessary to support the identification and dis-*
4 *ruption of Chinese-supported illicit financial*
5 *networks in Afghanistan.*

6 (3) *FORM.—The report under paragraph (1)*
7 *may include a classified annex.*
