A BILL

To prohibit the consolidated audit trail from accepting personally identifying information, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “American Customer
5 Information Protection Act”.

6 **SEC. 2. NO ACCEPTANCE OF PERSONALLY IDENTIFYING IN-**
7 **FORMATION.**

8 (a) IN GENERAL.—The consolidated audit trail may
9 not accept personally identifying information.

10 (b) EXCEPTION FOR LARGE TRADERS.—Subsection
11 (a) shall not apply to information accepted by the consoli-
12 dated audit trail in connection with large traders.

13 (c) DEFINITIONS.—For purposes of this section:

14 (1) CONSOLIDATED AUDIT TRAIL.—The term
15 “consolidated audit trail” means the consolidated
16 audit trail created by the national market system
17 plan approved pursuant to section 242.613 and sec-
18 tion 242.608 of title 17, Code of Federal Regula-
19 tions (or any successor regulation).

20 (2) LARGE TRADER.—The term “large trader”
21 has the meaning given that term under section
22 13(h)(8) of the Securities Exchange Act of 1934 (15
23 U.S.C. 78m(h)(8)).

1 (3) PERSONALLY IDENTIFYING INFORMA-
2 TION.—The term “personally identifying informa-
3 tion” includes—

4 (A) Social Security numbers;

5 (B) individual taxpayer identification num-
6 bers;

7 (C) other customer identifying information,
8 when taken alone or together, sufficient to iden-
9 tify an individual, such as names, addresses,
10 dates of birth, account numbers; and

11 (D) any other information the Securities
12 and Exchange Commission determines could be
13 defined as personally identifying information.
