Mr. BEYER (for himself and Mr. WITTMAN) introduced the following bill;
which was referred to the Committee on Armed Services

A BILL

To ensure the effective and appropriate use of the Lowest Price Technically Acceptable source selection process.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Promoting Value
5 Based Defense Procurement Act”.

6 SEC. 2. STATEMENT OF POLICY.

7 It shall be the policy of the Department of Defense
8 to avoid using Lowest Price Technically Acceptable source
9 selection criteria in inappropriate circumstances that po-

1 potentially deny the Department the benefits of cost and
2 technical tradeoffs in the source selection process.

3 **SEC. 3. REVISION OF DEFENSE FEDERAL ACQUISITION**
4 **REGULATION SUPPLEMENT.**

5 For new solicitations issued on or after the date that
6 is 120 days after the date of the enactment of this Act,
7 Lowest Price Technically Acceptable source selection cri-
8 teria shall be used only in situations in which—

9 (1) the Department of Defense is able to com-
10 prehensively and clearly describe the minimum re-
11 quirements expressed in terms of performance objec-
12 tives, measures, and standards that will be used to
13 determine acceptability of offers;

14 (2) the Department of Defense would realize
15 no, or minimal, value from a contract proposal ex-
16 ceeding the minimum technical or performance re-
17 quirements set forth in the Request for Proposal;

18 (3) the proposed technical approaches will re-
19 quire no, or minimal, subjective judgment by the
20 source selection authority as to the desirability of
21 one offeror's proposal versus a competing proposal;

22 (4) a review of technical proposals of offerors
23 other than the lowest bidder would result in no, or
24 minimal, benefit to the Department; and

1 (5) the contracting officer has included a jus-
2 tification for the use of a Lowest Price Technically
3 Acceptable evaluation methodology in the contract
4 file, if the contract to be awarded is predominately
5 for the acquisition of information technology serv-
6 ices, systems engineering and technical assistance
7 services, or other knowledge-based professional serv-
8 ices.

9 **SEC. 4. AVOIDANCE OF USE OF LOWEST PRICE TECH-**
10 **NICALLY ACCEPTABLE SOURCE SELECTION**
11 **CRITERIA IN PROCUREMENTS OF INFORMA-**
12 **TION TECHNOLOGY AND AUDITING.**

13 To the maximum extent practicable, the use of Low-
14 est Price Technically Acceptable source selection criteria
15 shall be avoided when the procurement is predominately
16 for the acquisition of information technology services, sys-
17 tems engineering and technical assistance services, audit
18 or audit readiness services, or other knowledge-based pro-
19 fessional services.

20 **SEC. 5. REPORTING.**

21 Not later than 180 days after the date of the enact-
22 ment of this Act, and annually thereafter for 3 years, the
23 Secretary of Defense shall submit to the congressional de-
24 fense committees a report on the number of instances in
25 which Lowest Price Technically Acceptable source selec-

1 tion criteria is used, including an explanation of how the
2 criteria in section 2 was considered when making a deter-
3 mination to use Lowest Price Technically Acceptable
4 source selection criteria.
