## A BILL

To amend section 6906 of title 31, United States Code, to provide funding for the payment in lieu of taxes program for an additional five years, to provide a five-year extension of the Secure Rural Schools and Community Self-Determination Act of 2000, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “PILT and SRS Cer-  
5 tainty Act”.

1 **SEC. 2. MANDATORY FUNDING FOR PILT PROGRAM.**

2 Section 6906 of title 31, United States Code, is  
3 amended to read as follows:

4 **“§ 6906. Funding**

5 “There is hereby appropriated to the Secretary of the  
6 Interior to carry out this chapter, out of any funds in the  
7 Treasury not otherwise obligated, \$465,000,000 for the  
8 first full fiscal year after the date of the enactment of this  
9 section and for each of the four fiscal years thereafter.”.

10 **SEC. 3. FIVE-YEAR EXTENSION OF SECURE RURAL**  
11 **SCHOOLS AND COMMUNITY SELF-DETER-**  
12 **MINATION ACT OF 2000 REFLECTING RECENT**  
13 **EXTENSION COVERING FISCAL YEARS 2014**  
14 **AND 2015.**

15 (a) EXTENSION OF PAYMENT AUTHORITY.—The Se-  
16 cure Rural Schools and Community Self-Determination  
17 Act of 2000 is amended—

18 (1) in section 101 (16 U.S.C. 7111), by striking  
19 “2015” both places it appears and inserting “2020”;

20 (2) in section 102(b)(2)(B) (16 U.S.C.  
21 7112(b)(2)(B)), by striking “2015” the second place  
22 it appears and inserting “2020”; and

23 (3) in section 103(d)(2) (16 U.S.C.  
24 7113(d)(2)), by striking “2015” and inserting  
25 “2020”.

1 (b) EXTENSION OF SPECIAL PROJECT AUTHOR-  
2 ITY.—Section 208 of the Secure Rural Schools and Com-  
3 munity Self-Determination Act of 2000 (16 U.S.C. 7128)  
4 is amended—

5 (1) in subsection (a), by striking “2017” and  
6 inserting “2022”; and

7 (2) in subsection (b), by striking “2018” and  
8 inserting “2023”.

9 (c) EXTENSION OF COUNTY PROJECT AUTHORITY.—  
10 Section 304 of the Secure Rural Schools and Community  
11 Self-Determination Act of 2000 (16 U.S.C. 7144) is  
12 amended—

13 (1) in subsection (a), by striking “2017” and  
14 inserting “2022”; and

15 (2) in subsection (b), by striking “2018” and  
16 inserting “2023”.
