Ms. BROWNLEY introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

## A BILL

To require any bus purchased for use in public transportation with funds provided by the Federal Transit Administration to be a zero-emission bus, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Green Bus Act of  
5 2021”.

1 **SEC. 2. ZERO-EMISSION BUS REQUIREMENTS.**

2 (a) IN GENERAL.—Chapter 53 of title 49, United  
3 States Code, is amended by inserting after section 5312  
4 the following:

5 **“§ 5313. Zero-emission bus requirements**

6 “(a) IN GENERAL.—Notwithstanding any other re-  
7 quirements of this chapter, not later than October 1,  
8 2029, any bus purchased or leased with funds provided  
9 under this chapter or otherwise provided by the Federal  
10 Transit Administration for purposes of providing public  
11 transportation shall be a zero-emission bus.

12 “(b) FEDERAL SHARE.—Notwithstanding any other  
13 requirements of this chapter, the Federal share of the cost  
14 of any zero-emission bus purchased or leased with funds  
15 provided under this chapter or otherwise provided by the  
16 Federal Transit Administration for purposes of providing  
17 public transportation shall be 90 percent.

18 “(c) DEFINITION OF ZERO-EMISSION BUS.—In this  
19 section, the term ‘zero-emission bus’ means a bus that,  
20 under any possible operational modes or conditions, pro-  
21 duces no exhaust emissions of—

22 “(1) any greenhouse gas; or

23 “(2) any air pollutant for which air quality cri-  
24 teria are issued under section 108 of the Clean Air  
25 Act (42 U.S.C. 7408) or for which a national ambi-

1 ent air quality standard has been promulgated under  
2 section 109 of such Act (42 U.S.C. 7409).”.

3 (b) CONFORMING AMENDMENT.—The table of sec-  
4 tions for chapter 53 of title 49, United States Code, is  
5 amended by inserting after the item related to section  
6 5312 the following new item:

“5313. Zero-emission bus requirements.”.

7 **SEC. 3. REPORT ON BEST PRACTICES IMPLEMENTING**  
8 **ZERO-EMISSION BUS FLEETS.**

9 (a) IN GENERAL.—Not later than 1 year after the  
10 date of enactment of this Act, the Secretary of Transpor-  
11 tation shall compile, and make publicly available, a report  
12 containing best practices and lessons learned by transit  
13 agencies and States that have implemented or are in the  
14 process of implementing zero-emission bus fleets.

15 (b) CONSULTATION.—In compiling the report, the  
16 Secretary shall consult with transit agencies, States, zero-  
17 emission bus manufacturers, and other stakeholders that  
18 the Secretary determines are appropriate.

19 (c) UPDATES TO REPORT.—The Secretary shall up-  
20 date the report required under subsection (a) annually.

21 **SEC. 4. PREFERENCE UNDER LOW- OR NO-EMISSION VEHI-**  
22 **CLE PROGRAM FOR OPERATORS WITH FULL**  
23 **FLEET TRANSITION PLANS.**

24 Section 5339(c) of title 49, United States Code, is  
25 amended by adding at the end the following:

1           “(8) PREFERENCE.—In awarding grants under  
2           this subsection, the Secretary shall give preference  
3           to applicants who have completed a full fleet transi-  
4           tion plan.”.
