## A BILL

To amend the Farm Security and Rural Investment Act of 2002 to improve assistance to community wood facilities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Community Wood Fa-  
5 cilities Assistance Act of 2021”.

6 **SEC. 2. COMMUNITY WOOD FACILITIES GRANT PROGRAM.**

7 Section 9013 of the Farm Security and Rural Invest-  
8 ment Act of 2002 (7 U.S.C. 8113) is amended—

1 (1) in the section heading, by striking “**EN-**  
2 **ERGY AND WOOD INNOVATION**” and inserting  
3 “**FACILITIES GRANT**”;

4 (2) in subsection (a)—

5 (A) in paragraph (1)(A)(iii), in the matter  
6 preceding subelause (I), by striking “woody bio-  
7 mass, including” and inserting “primarily forest  
8 biomass, including processing or manufac-  
9 turing”; and

10 (B) in paragraph (4), by striking “Energy  
11 and Wood Innovation” and inserting “Facilities  
12 Grant”;

13 (3) in subsection (b), by striking “Energy and  
14 Wood Innovation” and inserting “Facilities Grant”;

15 (4) in subsection (c)—

16 (A) in paragraph (1), by striking “35” and  
17 inserting “50”;

18 (B) by striking paragraph (2); and

19 (C) by redesignating paragraph (3) as  
20 paragraph (2);

21 (5) in subsection (d), by striking “exceed—” in  
22 the matter preceding paragraph (1) and all that fol-  
23 lows through the period at the end of paragraph (2)  
24 and inserting “exceed \$5,000,000.”;

25 (6) in subsection (e)—

1 (A) by striking paragraph (1);

2 (B) by redesignating paragraphs (2)  
3 through (8) as paragraphs (1) through (7), re-  
4 spectively; and

5 (C) in paragraph (1) (as so redesignated),  
6 by inserting “or market competitiveness” after  
7 “cost effectiveness”;

8 (7) in subsection (f)—

9 (A) by striking paragraph (2);

10 (B) by redesignating paragraphs (3) and  
11 (4) as paragraphs (2) and (3), respectively; and

12 (C) in paragraph (2) (as so redesignated),  
13 by striking “use or retrofitting (or both) of ex-  
14 isting sawmill” and inserting “construction,  
15 use, or retrofitting of forest products manufac-  
16 turing”;

17 (8) in subsection (g)—

18 (A) in paragraph (1), by striking “5  
19 megawatts of thermal energy or combined ther-  
20 mal and electric energy” and inserting “15  
21 megawatts of thermal energy”; and

22 (B) in paragraph (2), by striking “25 per-  
23 cent” and inserting “50 percent”; and

24 (9) in subsection (h), by striking “\$25,000,000  
25 for each of fiscal years 2019 through 2023” and in-

1           serting “\$50,000,000 for each of fiscal years 2022  
2           through 2026”.

3 **SEC. 3. WOOD INNOVATIONS GRANT PROGRAM.**

4           Section 8643 of the Agriculture Improvement Act of  
5 2018 (7 U.S.C. 7655d) is amended—

6           (1) in the section heading, by striking “**INNO-**  
7           **VATION**” and inserting “**INNOVATIONS**”;

8           (2) in subsection (c)—

9           (A) in the subsection heading, by striking  
10           “**INCENTIVIZING USE OF EXISTING MILLING**”  
11           and inserting “**EXPANDING FOREST PRODUCTS**  
12           **MANUFACTURING**”; and

13           (B) by striking “use or retrofitting (or  
14           both) of existing sawmill” and inserting “con-  
15           struction, use, or retrofitting for forest products  
16           manufacturing”; and

17           (3) in subsection (d), by inserting “50 percent  
18           of” before “the amount”.
