A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize certain recycled water projects, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Western Water Recy-
5 eling and Drought Relief Act”.

6 **SEC. 2. PROJECT AUTHORIZATIONS.**

7 (a) IN GENERAL.—The Reclamation Wastewater and
8 Groundwater Study and Facilities Act (43 U.S.C. 390h
9 et seq.) (as amended by section 512(a) of the Consolidated

1 Natural Resources Act of 2008) is amended by adding at
2 the end the following:

3 **“SEC. 16____. BENICIA WATER REUSE PROJECT.**

4 “(a) AUTHORIZATION.—The Secretary, in coopera-
5 tion with the City of Benicia, California, is authorized to
6 participate in the design, planning, and construction of re-
7 cycled water system facilities.

8 “(b) COST SHARE.—The Federal share of the cost
9 of the project authorized by this section shall not exceed
10 25 percent of the total cost of the project.

11 “(c) LIMITATION.—The Secretary shall not provide
12 funds for the operation and maintenance of the project
13 authorized by this section.

14 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
15 is authorized to be appropriated to carry out this section
16 \$6,750,000.

17 **“SEC. 16____. BRENTWOOD RECYCLED WATER PROJECT.**

18 “(a) AUTHORIZATION.—The Secretary, in coopera-
19 tion with the City of Brentwood, California, is authorized
20 to participate in the design, planning, and construction of
21 recycled water system facilities.

22 “(b) COST SHARE.—The Federal share of the cost
23 of the project authorized by this section shall not exceed
24 25 percent of the total cost of the project.

1 “(c) LIMITATION.—The Secretary shall not provide
2 funds for the operation and maintenance of the project
3 authorized by this section.

4 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
5 is authorized to be appropriated to carry out this section
6 \$5,200,000.

7 **“SEC. 16____. CENTRAL DUBLIN RECYCLED WATER DIS-**
8 **TRIBUTION AND RETROFIT PROJECT.**

9 “(a) AUTHORIZATION.—The Secretary, in coopera-
10 tion with the Dublin San Ramon Services District, Cali-
11 fornia, is authorized to participate in the design, planning,
12 and construction of recycled water system facilities.

13 “(b) COST SHARE.—The Federal share of the cost
14 of the project authorized by this section shall not exceed
15 25 percent of the total cost of the project.

16 “(c) LIMITATION.—The Secretary shall not provide
17 funds for the operation and maintenance of the project
18 authorized by this section.

19 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
20 is authorized to be appropriated to carry out this section
21 \$1,150,000.

22 **“SEC. 16____. CENTRAL PIPELINE DIRECT POTABLE REUSE**
23 **IN SANTA CLARA COUNTY.**

24 “(a) AUTHORIZATION.—The Secretary, in coopera-
25 tion with the Santa Clara Valley Water District, Cali-

1 California, is authorized to participate in the design, planning,
2 and construction of recycled water system facilities.

3 “(b) COST SHARE.—The Federal share of the cost
4 of the project authorized by this section shall not exceed
5 25 percent of the total cost of the project.

6 “(c) LIMITATION.—The Secretary shall not provide
7 funds for the operation and maintenance of the project
8 authorized by this section.

9 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
10 is authorized to be appropriated to carry out this section
11 \$16,250,000.

12 "SEC. 16 _____. CENTRAL REDWOOD CITY RECYCLED WATER
13 PROJECT.

14 "(a) AUTHORIZATION.—The Secretary, in coopera-
15 tion with the City of Redwood City, California, is author-
16 ized to participate in the design, planning, and construc-
17 tion of recycled water system facilities.

18 "(b) COST SHARE.—The Federal share of the cost
19 of the project authorized by this section shall not exceed
20 25 percent of the total cost of the project.

21 “(c) LIMITATION.—The Secretary shall not provide
22 funds for the operation and maintenance of the project
23 authorized by this section.

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
2 is authorized to be appropriated to carry out this section
3 \$8,000,000.

4 "SEC. 16____. CITY OF PLEASANTON RECYCLED WATER
5 PROJECT.

6 “(a) AUTHORIZATION.—The Secretary, in coopera-
7 tion with the City of Pleasanton, California, is authorized
8 to participate in the design, planning, and construction of
9 recycled water system facilities.

10 "(b) COST SHARE.—The Federal share of the cost
11 of the project authorized by this section shall not exceed
12 25 percent of the total cost of the project.

13 “(c) LIMITATION.—The Secretary shall not provide
14 funds for the operation and maintenance of the project
15 authorized by this section.

16 "(d) AUTHORIZATION OF APPROPRIATIONS.—There
17 is authorized to be appropriated to carry out this section
18 \$5,000,000.

19 "SEC. 16 . CONCORD RECYCLED WATER PROJECT.

“(a) AUTHORIZATION.—The Secretary, in cooperation with the Central Contra Costa Sanitary District, California, is authorized to participate in the design, planning, and construction of recycled water system facilities.

1 “(b) COST SHARE.—The Federal share of the cost
2 of the project authorized by this section shall not exceed
3 25 percent of the total cost of the project.

4 “(c) LIMITATION.—The Secretary shall not provide
5 funds for the operation and maintenance of the project
6 authorized by this section.

7 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
8 is authorized to be appropriated to carry out this section
9 \$1,000,000.

10 **“SEC. 16____. CONTRA COSTA COUNTY RECY-
11 CLED WATER PROJECT, PHASE 1.**

12 “(a) AUTHORIZATION.—The Secretary, in coopera-
13 tion with the Central Contra Costa Sanitary District, Cali-
14 fornia, is authorized to participate in the design, planning,
15 and construction of recycled water system facilities.

16 “(b) COST SHARE.—The Federal share of the cost
17 of the project authorized by this section shall not exceed
18 25 percent of the total cost of the project.

19 “(c) LIMITATION.—The Secretary shall not provide
20 funds for the operation and maintenance of the project
21 authorized by this section.

22 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
