## A BILL

To require the Department of Housing and Urban Development to fill all asset management positions located at non-core office locations of the Office of Multifamily Housing, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Preserving HUD’s  
5 Multifamily Field Offices Act of 2016”.

1 **SEC. 2. PRESERVING ASSET MANAGEMENT POSITIONS IN**  
2 **NON-CORE OFFICES.**

3 (a) PROHIBITION ON RELOCATION OF POSITIONS.—  
4 The Secretary of Housing and Urban Development may  
5 not relocate to any core office of the Office of Multifamily  
6 Housing of the Department, any asset management posi-  
7 tion (including any account executive, senior account exec-  
8 utive, and troubled asset specialist position) that, as of  
9 the date of the enactment of this Act, is located at a non-  
10 core office of such Office.

11 (b) BACK-FILLING OF POSITIONS.—Upon the occur-  
12 rence of a vacancy in any asset management position at  
13 any non-core office (including any vacancy in existence as  
14 of the date of the enactment of this Act), the Secretary  
15 may newly hire an employee to fill such position only at  
16 the same non-core office.

17 (c) DEFINITION OF CORE OFFICE.—For purposes of  
18 this section, the term “core office” means, with respect  
19 to the Office of Multifamily Housing of the Department  
20 of Housing and Urban Development, a regional hub office  
21 that is located in Atlanta, Chicago, Fort Worth, New York  
22 City, or San Francisco.

23 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

24 There is authorized to be appropriated to the Sec-  
25 retary such sums as may be necessary to cover costs of
