A BILL

To require certain passengers, employees, contractors, and subcontractors of Amtrak and air carriers to provide proof of vaccination against COVID–19 or a negative test for COVID–19 for certain transportation or employment, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safe Travel Act”.

1 **SEC. 2. REQUIREMENTS FOR AIR CARRIERS AND AIR-**
2 **PORTS.**

3 (a) IN GENERAL.—The Secretary of Transportation,
4 acting through the Administrator of the Federal Aviation
5 Administration, shall take such actions as are necessary
6 to require all airports and air carriers operating in air
7 transportation in the United States to require any patron
8 of such airport or passenger of such air carrier to—

9 (1) provide proof of vaccination against
10 COVID–19; or

11 (2) produce a negative test for COVID–19
12 within 72 hours before entering the airport or flying
13 in air transportation on such air carrier.

14 (b) REQUIREMENT FOR EMPLOYEES AND CONTRAC-
15 TORS.—All airports and air carriers operating in air trans-
16 portation in the United States shall require all employees
17 or contractors of such airport or air carrier to—

18 (1) provide proof of vaccination against
19 COVID–19; or

20 (2) produce at least once per week a negative
21 test for COVID–19.

22 (c) TESTING POLICY.—All airports and air carriers
23 covered under subsection (b) shall develop a testing policy
24 to comply with subsection (b)(2).

1 **SEC. 3. REQUIREMENTS FOR AMTRAK.**

2 (a) IN GENERAL.—Amtrak shall require all pas-
3 sengers of any train operated by Amtrak to—

4 (1) provide proof of vaccination against
5 COVID–19; or

6 (2) produce a negative test for COVID–19
7 within 72 hours before riding in interstate transpor-
8 tation on any Amtrak operated train.

9 (b) REQUIREMENT FOR AMTRAK EMPLOYEES AND
10 CONTRACTORS.—Any employee of Amtrak or any con-
11 tractor or subcontractor of Amtrak shall be required to—

12 (1) provide proof of vaccination against
13 COVID–19; or

14 (2) produce at least once per week a negative
15 test for COVID–19.

16 (c) TESTING POLICY.—Amtrak shall develop a test-
17 ing policy to comply with subsection (b)(2).
